

Norfolk County Council proposes to make a Temporary Traffic Regulation Order (the "Order") (NTRO11327) affecting the C288 Hall Road from 920 metres northwest of the U14390 Forge Lane for 300 metres north-westwards (the "Road") in the Parish of Aldborough and Thurgarton to facilitate pole testing works, the Road will be temporarily closed (except for pedestrian access) for the duration of the works/period the closure is necessary which is anticipated to be on the 10<sup>th</sup> July 2026, but may continue to be closed until the 21<sup>st</sup> August 2026 where the closure is still required beyond the anticipated dates.

Alternative route is via: Hall Road, Barningham Road, Aldborough Road, The Street, Barningham Road, Bessingham Road, Plum Lane, Mill Road, Red Barn Lane, Gibbet Lane, A148 Holt Road, B1436 Cromer Road/ Roughton Road/ Felbrigg Road/ Chapel Road, A140 Norwich Road, Aldborough Road, Church Road, Town Green, Thwaite Hill, Hall Road (Matlaske, Aldborough & Thurgarton, East Beckham, Aylmerton, Plumstead, Alby with Thwaite, Gresham, Upper Sheringham, West Beckham, Felbrigg, Beeston Regis, Hanworth, Roughton).

The works promoter for this closure is: Openreach.

Vehicular access will be permitted to a final destination in the Road where signs indicating such access is possible and permitted are in place.

The Order shall automatically revoke on the completion of the works when the closure is no longer necessary or otherwise on the 21<sup>st</sup> August 2026 without further notice.

If necessary, the restriction could run for a maximum period of 18 months from the date the Order is effective.

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the closure imposed by the Order shall be guilty of an offence.

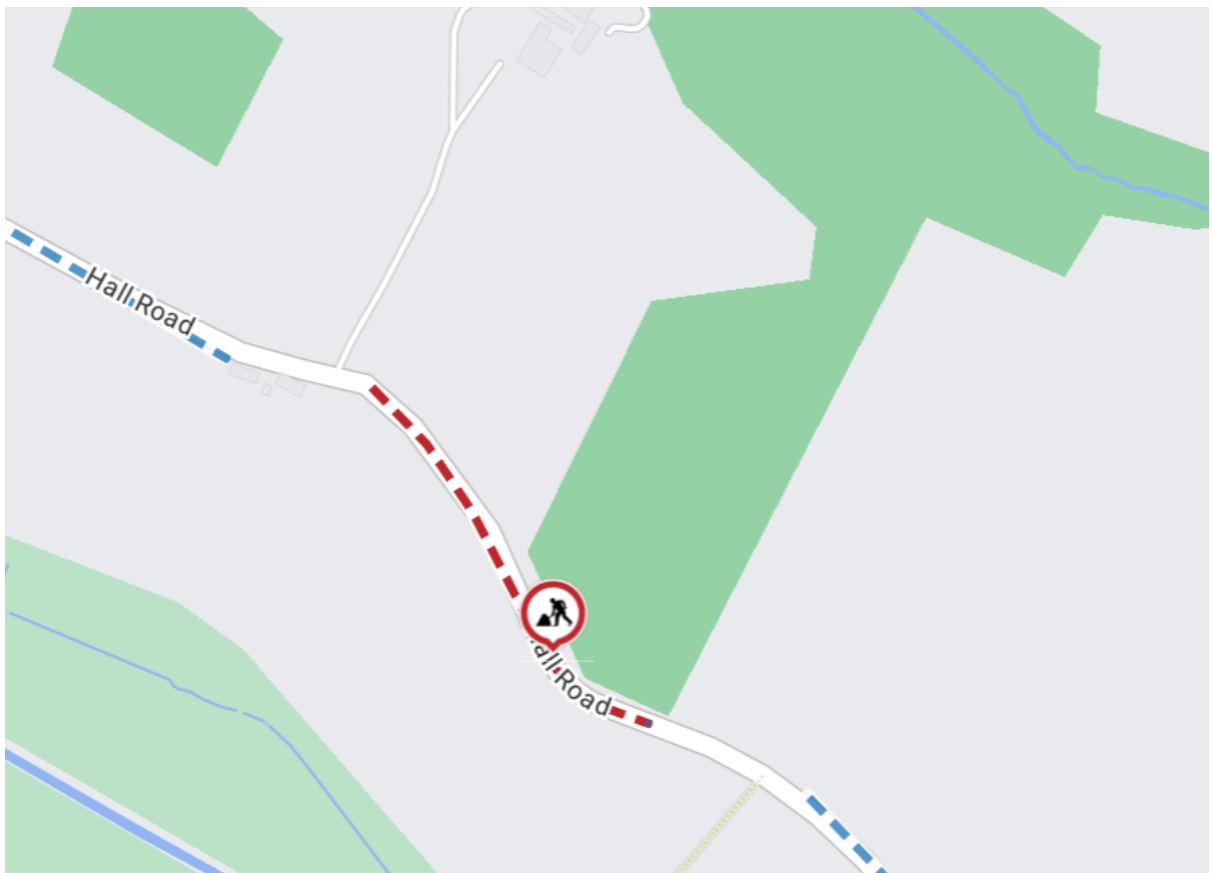
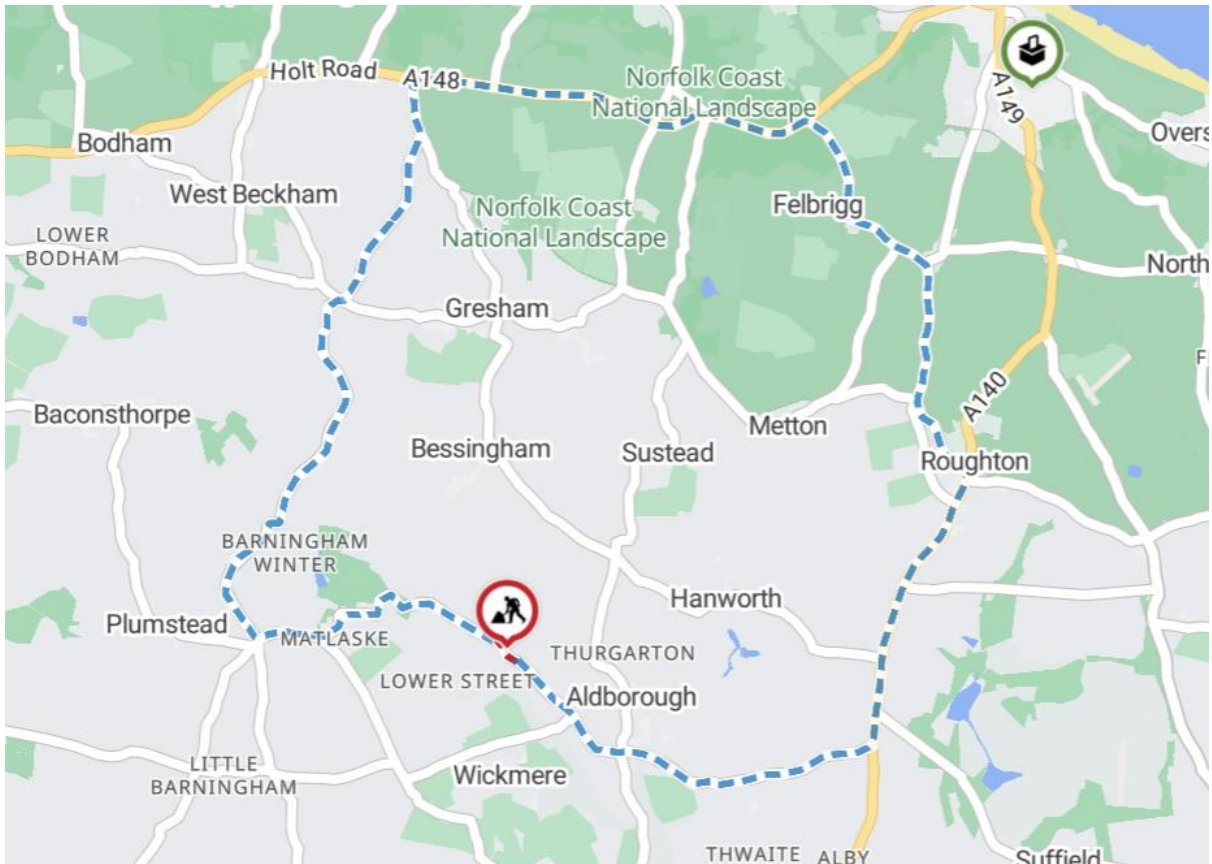
Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
