## 22/071 REPORT FROM CLLR. LEZLEY PICTON (SHROPSHIRE COUNCIL)

Cllr Picton shared information about books of condolence, etc.

Purple bins - These have now been distributed to those who put in a request for them. Owners of the new bins should note that there is a blank space on the front of the bin for you to put your address (using permanent marker).

Shropshire Council, like many other district and unitary councils, is facing a massive deficit under present conditions and is therefore reviewing its budget. Cllr Picton warned that funds will have to be concentrated on essential services, at the cost of other optional expenditure.

Cllr Picton left the meeting after this item.

#### 22/073 PROGRESS REPORT

- a) **SmartWater** Ongoing.
- b) Neighbourhood Fund spending (Jubilee) Cllrs voted to authorise a donation of <£500 for new strimming equipment.</li>
- c) Electricity for street lighting Only one company was able to provide a quote West Mercia Energy, a purchasing organisation endorsed by Shropshire Council. Although they cannot offer any savings on the energy tariff, they do have much lower standing charges. Therefore, their estimated costs for the parish council would be £680 p.a. of which £113 is standing charges. NPower (current provider) charges are c. £1080 p.a. of which around £750 is standing charges. Council agreed to move to WME (paying by Direct Debit) and mandates were signed.
- d) **Parking issues** Following letters to parents, pub employees, and an article in the parish newsletter, there has been some improvement. The parish council will continue to monitor the situation.

#### 22/074 GENERAL PARISH & HIGHWAY MATTERS

Please note: Most highway and general repair matters are best reported using *fixmystreet.com*. This will usually get the quickest results.

- a) It was noted that **pupil numbers at St Lucia's** are slightly higher than expected, with five more children having enrolled.
- b) Some residents had been concerned by **antisocial behaviour** and minor vandalism that had occurred during the summer months. Councillors heard that this has now abated. Councillors would like everyone in the village to know that they are always happy to be approached with any concerns and will do their best to get support from relevant sources if it is needed. Contact details for all parish councillors are on the website.
- c) JL expressed concern about the dangerous behaviour of some **cyclists** in the village and surrounding lanes.
- d) AB reported that the edge of the road is collapsing into the ditch, up past the shoot lodge. He will report this.
