Minute number 412/2025/A Members of the public – Resident Anne Wallbank, reported that several residents are concerned about the proposal to use the land at the Park Gate Inn PH to host caravans initially because the present state of the roads and also the space on Park Gate Road and Holly Hill Road both not afford enough space for a vehicle to turn a caravan onto and off the site. Anne also reported that yesterday there was no planning notice outside the Park Gate but there is today.

Members discussed the proposal, in 2013 a similar proposal was made for 4 caravans, which was refused.

The Caravan Club will determine the number of vans allowed on the site. The landlord is trying to make use of the parcel of land which has been neglected over a period of time and to generate more income for the public house, which has previously closed through lack of use and profit. The landlord confirmed that they would install a septic tank for the foul waste. The clerk will complete the enquiry form to the Caravan Club and register the parish council as a party with an interest in any conclusion.
