# Minutes of the Annual Meeting of Kemberton Parish Council Wednesday 8<sup>th</sup> July 7.30pm Kemberton Village Hall

# 20.1 Election of the Chairman

It was proposed, seconded and **resolved**, that Martyn Bidgood continue as Chairman for the ensuing year.

# 20.2 Declaration of acceptance of office

Martyn Bidgood signed the Declaration of Acceptance of Office.

# 20.3 Election of the Vice-Chairman

It was proposed, seconded and **resolved**, that James Rennison continue as Vice-Chairman for the ensuing year.

# 20.4 Chairman welcome and announcements

The Chairman welcomed everyone to the meeting, and thanked them for helping put social distancing and health measures in place.

# 20.8 Report from Shropshire Councillor

# 20.9 Public Participation Session

The member of the public present had raised Highways issues in the Annual Parish Meeting preceding the Annual Parish Council Meeting. The Chairman advised that he would deal with these issues under Highways

# 20.12 Highways

# 20.12.1 Travelling Community

There was some discussion on the impact on the parish of a recent visit by travellers.

It was reported that a lock was put on the fire hydrant in the village as it is illegal to take water from it.

Cllr Mark Lea reported that a fence had been broken and ponies put to graze on his field. Police did not seem to want to get involved, and advised him that it was a civil and not criminal offence. Shropshire Council would not take action either, and advised Cllr Lea to employ a private bailiff. He did so, a notice was served, and this course of action proved affective.

It was **agreed** that the Parish Clerk should draft a response to Shropshire Council expressing concerns at the impact on the parish and disappointment at the time it took to move trespassers on and the apathetic reaction of the police and Shropshire Council.

### 20.12.2 Condition of the Roads

Mill Lane and Park Lane have been marked out for potholes. Concerns were about the quality of work:

- Some pothole filling has not been completed
- Some of the work is not of high quality
- Parts of Field Lane has been ignored (all of the Lane past Field House)
- Grindle Road has not had any work
- Evelith Lane remains in poor condition

Cllr Angela Blount commented that 'Grindle Road is a track, not a road'.

Cllr Marytn Bidgood commented that it had taken Shropshire Council 'a while to get to us and it's a job half done'

# 20.12.3. Kemberton Junction

Kemberton Junction has been surveyed, and is on Shropshire Council's schedule as an improvement. The Chairman reported that the Police and Crime Commissioners Office had advised him that money from the Safer Roads Scheme would be allocated towards this project.

# 20.12.4 Other Highway Matters

Cllr Mark Lea raised the five day road closure planned for August in the middle of the harvest. Parish Clerk confirmed that she had filed a comment on this and would follow the matter up.

# 20.13 Correspondence

Correspondence had been received from Shropshire Council regarding Rennew

"Council is contacting the Parish regarding matters relating to Grindle House Farm and the unauthorised business operating from the site. The Parish will be aware planning permission has been granted at an alternative location to enable the Rennew/Imperial Bricks business to relocate away from Grindle House Farm. The Council has recently inspected Grindle House Farm to evaluate the quantity and volume of stock remaining at the site and inspected the new site to assess the level of available storage space at the new location. Alterations have been carried out at the new location which are largely complete to enable the remaining stock at Grindle House Farm to be relocated and the unauthorised use to cease.

With regard to timescales for cessation of the unauthorised use, there is a balance between removing the volume of stock away from the site as quickly as possible whilst not overburdening the local road network and minimising the impact of increased vehicle movements in the short term. The Council has requested the site to be cleared and the unauthorised use to cease no later than the end of September 2020 to which Apley Estates has agreed. The Council will inspect the site following this date to check compliance and will update the Parish following this."

The Parish Council were unanimously of the strongly held view that it had been let down by Shropshire Council - what had been decided by the Inspectorate has not been enforced. Cllr Philip Jones questioned the purpose of been a Parish Council if it was constantly being ignored and overlooked.

It was **agreed** that the Chairman, Martyn Bidgood, would liaise with the Chairs of Sutton Maddock, and Ryton and Grindle, to discuss a joint response about the lack of enforcement.

# 20.16.5 Online Banking

The Parish Clerk said that if there were further lockdown restrictions, being able to use online banking would be helpful. There was some discussion on the implications of security and the process for approving payments. The Parish Clerk said that approving payments would be the same as now but the payment would be by BACS not by cheque. SALC (Shropshire Association of Local Councils) advice is that the safest way for a Parish Council to do internet banking is to have an administrator set up the transaction and two signatories authorise it. Most banks offer this facility but it would need to be checked with the Council's bank.

It was proposed, seconded and **resolved** to move to online banking, subject to satisfactory security arrangements.

It was proposed, seconded and **resolved**, to add the Clerk as an administrator on the Parish Council's bank accounts.

# 20.17 Environment

# 20.17.1 Dog fouling

The Chairman has received several complaints about the amount of dog fouling in the village. It was commented that Field Lane had been particularly bad. The recent lockdown restrictions had meant that more people had time to walk about the village. There was some discussion on the potential for anti-fouling signs and their possible usefulness.

It was agreed that a reminder to villagers about dog fouling and consideration to others was put in in the newsletter report.

# Footpaths

Cllr Mark Lea has had several complaints from the public about the footpath by Hall Meadows. It has difficult to get past, overgrown, and has been moved to the field boundary rather than the diagonal path across the field. There is an electric fence up. There was some discussion on the width of the path and whether it still follows the public footpath route.

Cllr Mark Lea also reported that he had had members of the public comment on the obstructions on the footpath by Kemberton Mill. It looks like it has been re-routed without permission.

There was also some discussion about the path by the Linway over the old airfield. The Parish Clerk said she would follow up these queries with Shirehall.

# Hedegrows

Cllr Martyn Bidgood said that several members of the public had asked him about removing hedgerows to widen an entrance and if planning permission would be required. The Parish Clerk said she would make enquiries with the Planning Department at Shirehall.

# Village Hall Committee

The Chairman, Martyn Bidgood, had received a request from the Village Hall Committee for a Parish Council Representative. Cllr Giles Greenwood expressed his interest, as he volunteer handyman for the Village Hall.

It was proposed, seconded, and resolved that Cllr Giles Greenwood be the Parish Council Representative for the Village Hall Committee.
