C/22/033 **Apologies**

Mr Michael Porter had provided information as to why he would like to be a Cllr. It was circulated to the Council before the meeting. There were no questions. The Council unanimously agreed to co-opt. Mr Porter was welcomed to the Council.

- Cllr Boney queried access to the cemetery which had been partly obstructed by fallen trees. Cllr Foord confirmed that his contact would be undertaking the removal of the wood shortly.

C/22/038 County and Borough Councillor Reports, PCSO report

Neither the Borough nor County Councillor were present. TVBC had supplied a report. There were no comments.

C/22/039 Infrastructure Issues

a. Phone Boxes

Cllr Lawrence said he would take on responsibility of the phone boxes.

b. Trout Pond

The Clerk had written to the Fishing Club to ask for funding for the project but had not had a reply. She and Cllr Jackson had asked businesses on the High Street to contribute and Robjents was willing to contribute £100. Cllr Drew had agreed to grant £1000. There had been no feedback from TVBC.

c. Pocket Park/Land Behind the toilets

There was no progress on producing a proposal.

d. Cycle Path

Cllr Drew had been asked to chase HCC.

e. Lily's path

HCC had written to Cllr Drew to say they were prepared to scalp the rougher area of the path. Cllr Foord expressed scepticism that this would be satisfactory. It was agreed that it would be better if HCC granted the money to SPC, for SPC to undertake the work.

f. Use of Pavement by traders

HCC had visited the High Street but had not seen any infringement of the pavement licencing. Cllr Lawrence expressed frustration that HCC were not taking responsibility for the infringements that caused difficulties to less able residents. He said that HCC should be written to in order to put it on the record that SPC did not share HCC's view and that the matter was solely in HCC's hands. This was agreed.

C/22/040 Test Valley School

The member of the public, Mr David Hall, who was a governor of Test Valley School asked to speak to the Council. He confirmed that Test Valley School was proposing to join a Multi Academy Trust (MAT). He said that the school

had 440 pupils but it could be double that. Andover schools were now improved and County had withdrawn support for transport. He said that the school had been looking for partner to federate with or formally to join other schools and had been investigating the most appropriate option. Mindful that it was government policy that by 2030 all schools should have be an academy the preferred choice was to join HISP academy Trust. The intention was to create a regional hub of excellence which would benefit the education in the whole area. He said the school was now entering into a formal consultation process but commented that so far there were no areas of concern. He said that by going down this route the school would secure a good strategic direction with links to impressive organisations. He commented that the project to build a new swimming pool was likely to go ahead. He said that a new head teacher had been appointed and would start in September. He asked the Council for their feedback as a consultee. The Council was supportive of the chosen way forward and asked Mr Hall to communicate this to Test Valley School.

Cllr David Drew joined the meeting

C/22/041 **Traffic Safety**

Cllr Bell commented that there was no progress although the report had now been referred to an HCC manager for comment.

C/22/042 **High Street**

a. Update on TPWG

Minutes from the recent meeting on the TPWG had been circulated to the Council. Cllr Boney informed the Council that a survey was now taking place on the High Street. He said that the survey was to work out if parking effected how visitors spent their money and the data would be used to inform a meeting with HCC at the beginning of July. He said that at the meeting he hoped to be able to find out what HCC's plans were for Stockbridge and if that included paid parking. He said that Stockbridge was a destination town and that paid parking would cause damage to the economy. He felt that businesses were supportive of this view. He said the survey results were encouraging so far with 350 sheets completed and evidence was that visitors had come long distances. Cllr Foord commented that this might not be the case outside the co-op.

b. High Street Re-Design

This was due to be discussed with HCC at the July meeting.
