### Publication of the Chelford Neighbourhood Plan (Pre-Submission Version)

# The Neighbourhood Planning (General) Regulations 2012 (Regulation 14)

Chelford Parish Council, as the qualifying body, has prepared a Neighbourhood Plan for the period to 2030 (the Plan) for Chelford Parish with the help of the local community. The Plan sets out a vision for the future of the Parish and planning policies, which will be used to determine planning proposals locally.

Chelford Parish Council is now inviting comments on the proposals in this Pre-Submission version of the Plan before it is submitted to Cheshire East Council for formal consideration and wider consultation.

The consultation opens for comment on 30<sup>th</sup> October 2018. The deadline for comments to be received by Chelford Parish Council is 5pm on 11<sup>th</sup> December 2018.
