Eighty five accommodation units have been built in Mardol House and the main reception will be in Rowley's House, with the teaching at The Guildhall. The objective is to have 2500 students.

#### (i) Bus shelter repairs

The clerk presented draft plans for the Wroxeter Roman City shelter. It was agreed to request that the gap by the bracket at the front is removed and not put a window in the side. Cllr. Nelson felt that a larger overhang may be needed and would visit the site to assess this.

#### (ii) Community concerns

It was **<u>RESOLVED</u>** to submit the following community road safety concerns to Shropshire Council, for inclusion in the 2016/17 programme:

Priority 2	Rushton	Junction by Upper Farm, Rushton - Concern re speed/visibility at this junction
Priority 3	Severn Way (where walkers cross the road)	Signs needed from either approach to warn people to slow down

1. Need to keep vegetation/hedges at verges and junctions trimmed back.

2. Visibility from the site of the bus shelter by the Roman City - there is now a fence where the hedge previously was. We would like to ask that the grass where the old hedge was is
