80/23. Reports from other meetings

No other meetings were attended

81/23. Traffic Calming Report and Pytchley Crossroads update

The clerk contacted Ian Boyes to relay the councils preferred design for Northampton Road. It was requested to only carry out consultation on the preferred design.

Pytchley Crossroads

The clerk met with the clerk at Pytchley Parish Council to create a coordinated response to NNC Highways in regards to Pytchley Crossroads after the recent spate of accidents. Matthew O'Connell (Safer Roads Team Manager) was contacted but said as the approach to this junction in all directions is heavily engineered and would be clear to the careful and competent motorist, his team would not be able to assist directly at this location as their primary delivery is speed enforcement.

A discussion took place and it was agreed that accidents are down to driver error but there also seems to be an underestimated high volume of traffic around the crossroads that is not being recognised by NNC Highways. Drivers are travelling at high speeds and going straight over the crossroads without checking. The majority of accidents seem to be coming from drivers exiting Pytchley towards the A43 and hitting oncoming traffic from Orlingbury – Broughton Road. Visibility is also hindered by a hedge.

Action: Clerk to ask if the Broughton direction post could be reinstalled and fluorescent signs appointed. Also ask again if a traffic monitor could be installed to measure volume of traffic. Contact Pytchley clerk again to see if they want to borrow Broughton SID and locate it on the give way posts in their parish.

Cransley Hill

Ian Boyes confirmed he has chased up the order for the 30mph sign for Cransley Hill last month with the maintenance team. The contractor is working through a large backlog of works, but I have asked for this to be given priority as soon as their resources allow.

Bus stop

The clerk was contacted by the senior public transport Officer, Elise Northfield as concerns had been raised regarding regular missed pick-ups due to cars parked in the vicinity of the bus stop at Kettering Road/Gate Lane, Little Cransley, Broughton, whereby the bus driver is unable to see in advance that someone is standing at the stop.

A discussion ensued and as resident properties adjacent do not have off road parking facilities and the road does not accommodate an area where the bus could stop anyway, it was agreed that the clerk would contact the bus company to see if the bus stop sign could be attached to the nearby lamp post instead for better for visibility.

Action: Clerk to contact First Bus.

82/23. Community & Police Report

Police Report

The chair and clerk were in correspondence with the police over anti-social behaviour that was taking place around the village and in the Pocket Park.

The clerk asked for a greater police presence in Broughton and invited PCSO Christine Duggan 7191 to the monthly meetings but unfortunately she has been ill and is currently office bound at the moment.

The working group will now meet to make a design plan for planting. It was agreed that as there is £1k set aside in the budget for the garden, it will be used to employ a company to do the manual work.

A discussion then took place on double taxation in respect to the poor management of grass verges by NNC and the possibility of BPC paying for additional cuts. It was agreed that the clerk would contact NNC and ask how much is budgeted and paid for by Broughton residents for grass cutting and how many visits are they contracted for per year.
