10/26 PROPOSED HOUSING DEVELOPMENT OFF BORASTON DRIVE

11/26 GROUND MAINENANCE CONTRACT

Only one tender was received for the ground maintenance contact, although three had been sought. It was agreed that the contract would be awarded to MTM Contracting Limited for a period of three years with a 5 per cent increase each year.

12/26 PATH FROM WORCESTER ROAD TO VILLAGE HALL CAR PARK

An email had been received from a resident stating that the light on the path between Worcester Road and the village hall car park was not bright enough and the cycle bar in Stanbrook Road and bollard at the entrance to the village hall car park were not adequately visible.

The Chair and Clerk had investigated the claims and felt that the light was adequate but the cycle bar and bollard were not adequately visible. The Clerk has sought permission from Shropshire Council as the cycle bar and bollard belongs to them, not yet received, to paint both with fluorescent paint. Clerk to contact Shropshire Council again and advise the resident of the council's decisions.

13/26 HUB AT BURFORD PRIMARY SCHOOL

An email had been received from Burford Primary School asking for the council's opinions and comments on creating a hub within the school to cater for special needs children. It was unanimously agreed that it was a good idea, Clerk to complete the survey form and return.

APPENDIX A

Report from Bridget Thomas, Burford Parish Council Chair.

I had a long conversation with the senior technical Officer for Shropshire Highways regarding the dreadful state of the A456 from the Swan Garage to Boraston Drive. He agreed that work should be carried out on the road surface in that area, but although his team regularly carries out inspections, there is a lack of funding to address the problems. He did mention the removal of one of the raised areas, but this would not be carried out in the immediate future. I mentioned the fact that lineage work was to be carried out along the A456 where, due to the road repairs, the white lines had been obliterated. I asked if the repairs to the aforementioned area were not more important and he mentioned the different funding pots available to SCC for different types of work. I will try "fix my street again"
