Grant Application Form

NOTES TO HELP YOUR APPLICATION

All the information you provide helps us consider your application.

The Parish Council sets aside a limited sum of money to finance grants each year and applications may be submitted at any time. Whatlington Parish Council has only limited powers to pay grants to local groups and those we have are set out in law. Our only income is derived, ultimately, from the Council Tax paid by Parish Residents. It is vital, therefore, that the purpose of your grant has a community benefit to “a number of local residents.”

The grant you request must be for a specific purpose carried out by your group and not simply “general fund-raising” or “overheads.” Your group must be “not for profit,” with membership and activities based (wholly or largely) in Whatlington Parish or for the benefit of residents of Whatlington Parish.
