# 174/09/23: TO APPROVE THE MINUTES OF THE COUNCIL MEETING HELD ON WEDNESDAY 19 JULY 2023

# 176/09/23: TO RECEIVE REPORTS FROM EXTERNAL AUTHORITIES; AGENCIES; COMMITTEES AND PORTFOLIO MEMBERS

# (a) Sergeant Grasty from Kent Police Dartford Community Safety Unit

Sergeant Grasty was unable to attend the meeting but offered to meet with Council Members at a later date.

### (b) **Borough Councillor Report**

Councillor P Denman provided a verbal report.

Key points included: **Borough Casework** in respect of Ladywood Road Tree Preservation Order; Hill Rise potholes; footpath clearance; social housing; Borough Policing Strategy and the success of the Darenth Community Litter Picks which had, to date, resulted in 110 sacks of waste being collected.

**Dartford Borough Council** matters regarding the Connect C1 Bus - a 30-minute extended start time had been added, a £2 flat rate fare would be charged, it would have the convenience of being 'hailable' and would now include the Coombfield Road area.

The Orchard Theatre closure may extend beyond the end of October 2023 and quotes for roof repair were currently being sought.

The Chairman thanked Councillor Denman for his informative report.

(c) Streetlights update – The Chairman moved discussion for this matter to after Agenda Item 182/09/23 EXCLUSION OF PRESS
& PUBLIC due to the financial and contractual information to be discussed.

**RESOLVED:** That the Clerk actions any decisions made in respect of streetlight considerations.

#### (c) **Bunding Working Party**

Councillor Holmes reported that Thames Water had installed bunding to grass verges outside their Green Street Green Road plant and that, to date, the measures were working well. The company had been experiencing sight and safety issues due to parking on the verges. The Clerk had written to Thames Water on behalf of the Chairman to thank them for their input and for funding the project.

The Chairman thanked the Bunding Working Party for their work over the Summer months and for bringing the matter to a conclusion.

# 177/09/23: TO NOTE FINDINGS AND RECOMMENDATIONS MADE BY KENT COUNTY COUNCIL IN RESPECT OF THE DARENTH PARISH COUNCIL HIGHWAYS IMPROVEMENT PLAN

The Clerk reported that Kent County Council's West Kent Community Engagement Team had visited the area around Greenlands School following submission of the Parish Council's Highways Improvement Plan. The Engagement Team Leader confirmed that there was a relatively new yellow backed warning sign (with School plate) travelling northbound. An older sign which needed to be removed and no sign displayed when travelling southbound.

The Design & Delivery Team confirmed the removal of the old sign travelling northbound and the installation of a replacement sign in the southbound position. These elements of the project are to be funded by Kent County Council.

It was also confirmed that concerns regarding the right-hand turn will be progressed by the Community Engagement Team following further investigation and consultation with Greenlands Primary School.

The Chairman thanked the Clerk for her work in respect of the Darenth Highways Improvement Plan.

# 178/09/23: TO CONSIDER PRICING IMPLEMENTATION BY PARISH COUNCIL WEBSITE PROVIDER

With the Parish Council's current website provider, HugoFox transitioning to a paid subscription model in place of their previously free services, Members considered options for the continuation of this beneficial amenity and to ensure alignment with features and services currently offered. The website service will remain free until the 4<sup>th</sup> October 2023.

Members noted that to retain our current website functionality and benefits, a monthly fee of £19.99 + VAT would be charged. The package includes an option for cancellation at any time.

Change of use of the former care home (Use Class C2) to a mixed use comprising residential accommodation for employees of Vineyard Farms Ltd as well as for a residential training centre for the same persons. Erection of a new screening wall to the front of the property, new fence and gate to the rear, formalised parking areas and pedestrian routes. (Variation of conditions 1 and 2 of planning

permission DA/22/01274/FUL in relation to the provision of an acoustic fence in lieu of a screening wall).

**Observations:** Members resolved to submit the following objection to the Planning Authority: The Parish Council notes the reason for the variation of the Condition but would make the point that since the temporary permission was granted there has been more than sufficient time for the 'conditioned' screening wall to be built. The Parish Council would therefore ask that the contention that the 'comparable results' from the erection of an alternative 'acoustic fence' are adequate to ensure that there is no adverse impact on the quality of the lives of residents of the adjacent properties.
