DODDINGTON PARISH COUNCIL

Minutes of the Parish Council Meeting held in Doddington Village Hall on Monday 8 September 2025

1. APOLOGIES

Cllr Coates welcomed everyone to the meeting.

All Members were present.

Apologies had been received from County Councillor Rich Lehmann: apologies noted.

2. DECLARATIONS OF INTEREST

Cllr Attwood declared a pecuniary interest in item 9.i. Proposed Highsted Park development as landowner within the application.

It was agreed to move the item to the end of the meeting.

4. MINUTES OF THE PARISH COUNCIL MEETING HELD ON 14 JULY 2025

It was **AGREED UNANIMOUSLY** to accept the minutes as a true record of the meeting. Cllr Coates duly signed the minutes.

5. MATTERS ARISING

Drain Inspection

Cllr Jones reported that the bi-annual drain inspection on the Old Lenham Road took place on 27 July.

Post Office

Cllr Jones said the visiting Post Office service at The Chequers, on Wednesday 10-12 noon, had been suspended several weeks ago due to staff shortages. A new operative had now been recruited and discussions were ongoing about restating the service

Cllr Coates reported that he will attend the next meeting of Newnham Parish Council on Thursday.

Local Government Reorganisation

Cllr Coates informed Members that he has been attending meetings regarding the review.

Swale Eastern Area Committee

Cllr Fraser reported that he had attending the recent meeting of the Swale Eastern Area Committee: discussions included public toilets in Swale; cycleways and footpaths in and around Faversham; a presentation on the boundary of Blean Wood; flags appearing in Faversham and the perceived influence of the Far Right: there was nothing pertinent to Doddington.

Cllr Coates thanked Cllr Fraser for attending the meeting.

PC Jez Chittim was unable to attend the meeting.

7. PUBLIC QUESTION TIME

No members of the public were in attendance.

8. HIGHWAYS

Cllr Coates reported the pavement on Chequers Hill has been cleaned. The pavements on The Street, Chequers Hill and to Newham reported to KCC Highways have been risk assessed and they have concluded that no action was required.

More complaints have been received regarding HGV's using inappropriate routes through the village, especially the Old Lenham Road. It had previously been agreed with KCC Highways that the Parish Council would monitor the situation. New evidence of this problem has now been provided by a resident and Cllr Coates had discussed this with his KCCH contact. As a result, KCC Highways will now install extra "NO HGV" signage and fund this. This will be added to a Parish Council Highways Improvement Plan.

15. ANY OTHER BUSINESS

Faversham Foodbank: Following a previous request for funding support, the council had asked for further information to be provided. Cllr Coates said the Faversham Foodbank had responded saying that the largest cost is the hall hire and that there is no way of assessing who uses the Foodbank. There is concern that the service, currently situated in Faversham, is not reaching vulnerable people in the parishes.

Councillors were sympathetic to supporting the project but were unsure if residents would benefit from this new outreach service which would be located in Eastling Village Hall which was not accessible by bus.

Cllr Coates **PROPOSED** not to support the Eastling hub at present but will monitor the situation: **SECONDED** by Cllr Clark: **AGREED UNANIMOUSLY**.

Cllr Lumsden reported that there is an issue with parking on pavements, especially by visitors and also dog fouling in the village.

ACTION: item for newsletter.

Cllr Fraser asked if he should attend the Kent County Playing Fields AGM, there was nothing on the agenda of interest to Doddington. It was agreed not to attend.
