Parish Council Meeting held on 13th November 2025 at 7:30pm, Moulsford Pavilion

Minutes

- 1. Receive Apologies for Absence: None
- 2. Receive an application for Parish Councillor and agree to co-opt: It was agreed to co-opt Liam Kelly as Parish Councillor. Acceptance of Office signed Clerk to send Register of Interests for completion and set up Parish email.
- 3. Receive Requests for Dispensations, Declarations of interest, gifts, hospitality: None
- 4. Approve Minutes of previous Council meeting: Proposer MMJ, 2nd SP, agreed and signed
- 5. Matters Arising: None
- **6. Receive a report from the District Councillor and County Councillor:** Written Reports received JHS reported on HART and suggested requests are made soon. (revisit item for AMS report)
- 7. Receive Questions and Contributions from Members of the Public:

7 Members of the public spoke regarding their views on the removal of the Monkey Puzzle tree, some requested it be reinstated, others requested that it was not.

8. Review Planning Applications received (and any other received between circulation of this agenda and the meeting):

Applications

P25/S3270/HH - Karethia 12 Glebe Close Moulsford OX10 9JA - Proposed merge of granny annex into main house. (12th November): **No Strong Views**

P25/S3437/HH - Thatchwell Moulsford OX10 9JD - Conversion of garage into home office and storage, with oak framed bay window: **No Strong Views**

Decisions: Noted

P25/S2801/HH - 11 Underhill Moulsford OX10 - Application proposal, including any amendments: Garage conversion into habitable accommodation, erection of a rear extension, erection of infill porch roof installation of solar panels and changes to the fenestration (as amended by plans to alter fenestration associated with the garage conversion received on 10 October 2025) – Granted

P25/S2936/HH – Grange Stables – Kitchen Extension – Granted

From this point, due to the requirements of the agenda, items were taken out of order (the order now reflects order taken and not agenda item order)

- 9. Agree ICO Data Protection Renewal £52 (annual reduction of £5 if paid Direct Debit Agree): It was agreed to renew and pay by direct debit, Proposer SP, 2nd MMJ
- 10. Approve Bank Reconciliation: Approved and signed
- 11. Approve Payments: Approved (Attached).

It was **agreed that** the Ionos HiDrive subscription be cancelled due to it not being used.

12. Consider and agree 26/27 Budget and Precept: CPI currently 3.8%, it was agreed (in principle) that the precept be increased by 4%

Items for consideration in the next year's budget:

- Additional Allotments costs
- Playground Maintenance including Basketball court and backboard approx. cost £6000
- Additional grounds maintenance costs

Clerk to provide line by line with proposed increases.

Councillors to provide proposals for additional or increased costs for approval at December meeting.

- **13.** Take an update and agree action regarding Management 'Committees': HS reported on the requirement for the MPMC and MEC to carry their own insurance (given the status of their groups). It was agreed that the Parish Council would pay for the insurance in the first year (£380.75 for each). Proposer HS, 2nd MMJ.
- 14. **Discuss and agree action regarding Monkey Puzzle Tree:** ME proposed that the Monkey Puzzle tree be replanted in its original location. He outlined reasons for replanting and referred to expert advice received.

SP reported on the Risk Assessment undertaken (attached), noting the implications for maintenance and that a potential injury claim could reach £30,000. She also advised that the original planting of the tree in 2022 had not been the subject of a formally minuted decision.

LK supported replanting.

MMJ referred to the Oxfordshire County Council "right tree, right place" principle. Owain of Devey Tree Services confirmed verbally that the Monkey Puzzle tree would satisfy this principle if replanted in its original location.

MMJ summarised the reasons for the recent tree removal and explained that, since an alternative location previously offered was no longer available, she now supported

replanting, with the option to remove the tree if it became problematic in the long term. She also noted that other expert advice circulated to councillors indicated that planting a Monkey Puzzle was not recommended, and that all councillors had been copied on emails from August onwards outlining the planned tree removal.

HS confirmed that the tree would be included in the routine formal tree safety survey and reported that a parishioner had offered to provide fencing at no cost.

ME amended his proposal to replant the tree in its original location with the offered free fencing. Proposed ME, seconded MMJ. The motion was **agreed**.

15. Consider and agree action regarding Traffic Management 20mph limit: HS moved to start the process of adopting 20mph limit through the village. First instance would be a short local Parish survey whence if supported it would go to OCC's Statutory Consultation.

JHS reported that the specialists would look at the application, and that 20mph had been successful in reducing overall speeds and accidents.

ME raised the question if whether other options for speed reduction, such as road markings had been attempted elsewhere, prior to introducing 20mph.

It was **agreed that** the short local survey was undertaken. It was **agreed that all Councillors** would work together to deliver the survey prior to the next meeting.

- 16. Discuss and accept quote for Playground Inspection, Inspectonline £96.50 + VAT: Approved
- 17. To take an update and agree actions regarding the shorter run of fencing (alternative to dog fencing proposal previously agreed at cost of £3500): MMJ reported that an approx. 7m run of fencing would cost £950 plus VAT approx. With the benefit of removing the cost of replacing the bin and post (cost saving £183 plus VAT), to reduce the likelihood of dogs running directly on to the play area.

MMJ reported Sign and installation cost of £364, HS reported that another zero cost quote was possible. It was **agreed that** this project should go ahead at the costs stated, unless the zero-cost quote is obtained. **HS and MMJ to action**.

18. Discuss and agree action regarding Pavillion Roof Survey, Quotes received:

CJM £220 + VAT for Survey, including suitability for Solar (survey cost taken from subsequent works)

CJM £1741.21 + VAT for repairs

Premserv £2150 for Survey, including suitability for solar

It was **agreed that** the roof survey should be extended to include a survey of the whole Pavilion. ME reported that he knew of a company that would be able to offer the full service. It was **agreed to defer** the item to the next meeting, **ME to obtain** the quotes.

19. Take an update and agree actions on Allotments:

SP reported that the HoT was again not ready due to one item conflict item (no-dig area). SP also reported that the allotments have been invoiced in arreas, but that the upcoming year will be invoiced in advance, and that all lessees will need to be moved to the new contract. It was **agreed to** do this in two segments.

It was **agreed that** the rental year should run from April to March, in line with the Council financial year.

Item 6 Revisit: AMS reported on the Unitary Council, and it's potential move forward. Also reported that the Local Plan is still in place, the 5 year housing supply will need to be looked at, but that other policies are valid. AMS reported that the Councillor grant applications are open.
