"The engineer reported that the sim required a 'reset' upon arrival on site to activate."

The site team did not find any individual faults on site. However the cars are finding It difficult to activate the sign coming up the hill.

The engineer tried to lower the sign as much as possible but still found it difficult to activate the sign as it is looking over the top of cars and only seeing high sided vehicles such as vans.

The issue is still under review and will most likely require another visit to rectify the issue.

Once a plan is put in place someone will be in touch to update us."

Following the earlier consultation this year, the Boundary Commission has produced draft proposals for amendments to electoral division boundaries in Shropshire. Quatt Malvern is currently part of the Alveley Division, a single member ward comprising the parishes of Alveley and Romsley, Claverley and Quatt Malvern.

The Boundary Commission propose to create a new single member ward comprising Alveley, Romsley Quatt Malvern and Quatford which will be called Bridgnorth Rural. Claverley will be incorporated in to a new ward with Worfield. Further information can be obtained
