Location: 29 Asher Reeds, Langton Green, Royal Tunbridge Wells

Proposal: Demolition of conservatory and erection of orangery and attached store

Decision: Remain neutral - leave to Planning Officer

Comment: The plan accompanying the application is incorrectly annotated showing the

property as No. 33 when it is in fact No. 29 Asher Reeds.

#### TW/12/01981/FUL/RE4

Location: The Barn, Pokehill Farm, South Farm Lane, Langton Green, Royal Tunbridge Wells Proposal: Demolition of existing dwelling and farm out-building, construction of replacement dwelling

Decision: Remain neutral – leave to Planning Officer

Comment: Because of the impact on this rural setting the materials should be sympathetic to

the neighbouring properties.

#### TW/12/01998/TPO/DMD

Location: 35 The Boundary, Langton Green, Royal Tunbridge Wells Proposal: TREES: T2 YEW – Crown lift. Remove overhanging branches

Decision: Remain neutral – leave to Tree Officer

Comment: Having asked for and being given an extension of time for planning comments it concerned us to find that this application had already been determined prior to our meeting.

Location: St Michaels's, Burrswood, Groombridge, Royal Tunbridge Wells

Proposal: Listed Building Consent – Replacement of failed downpipes on southern elevation

Decision: Remain neutral - leave to Conservation Officer

## TW/12/02126/HOUSE/KLM

Location: Windy Ridge, Furzefield Avenue, Speldhurst, Royal Tunbridge Wells

Proposal: New pitched roof to front of existing flat roofed garage

Decision: Recommend approval

Comment: This proposal will improve the street scene.

#### TW/12/02135/HOUSE/RE4

Location: Meads House, Langton Road, Speldhurst, Royal Tunbridge Wells

Proposal: Single storey rear extension with basement underneath, single storey extensions on both sides of dwelling, dormers to front and rear elevations and conversion of garage to

habitable living accommodation ancillary to the main dwelling

Decision: Remain neutral - leave to Planning Officer

Comment: No information is included within the application on the percentage increase in

volume.

#### TW/12/02173/HOUSE/GM2

Location: The Mill Bungalow, Speldhurst Hill, Speldhurst, Royal Tunbridge Wells

Proposal: Log cabin

Decision: Remain neutral – leave to Planning Officer

Comments: There is no supporting information or justification on the use of and need for the proposed building or what is happening to the existing structures not shown on the plans. Also no details of colour of cladding materials have been provided. They should be neutral in

colour.

### TW/12/02196/FUL/RE4

Location: Hollonds Farm, Langton Road, Langton Green, Royal Tunbridge Wells

Proposal: Four bedroom, two storey dwelling

Decision: Remain neutral – leave to Planning Officer

Comments: Concern expressed at additional traffic exiting onto the A264, the roof height of the

proposed building and whether there is adequate off-street parking.

#### TW/12/02227/HOUSE/KLM

Location: Maples, Monteith Close, Langton Green, Royal Tunbridge Wells

Proposal: Single storey rear extension

Decision: Remain neutral – leave to Planning Officer

## TW/12/02235/HOUSE/SF1

Location: Hillside, Bullingstone Lane, Speldhurst, Royal Tunbridge Wells

Proposal: Open fronted double car barn with undercroft storage

Decision: Recommend refusal

Comments: Concern expressed that the property is outside the Limits to Built Development and within the Metropolitan Green Belt and that this property has already been increased in size by over 50%. If TWBC is minded to approve the application we would ask that there is a

non-severance condition put in place.

### PAG/KCC/TW/0259/2012

Location: Broomhill Bank School, Broomhill Road, Royal Tunbridge Wells

Proposal: Construction of external lift shaft

Decision: Remain neutral – leave to Planning Officer

Comment: Broomhill Bank School is a valuable asset to the community.

## 7. Items for Information:

Cllr Mrs Horne raised the matter of the trees that have been felled at the junction of Burnt House Lane. After discussion it was AGREED that the Assistant Clerk ask the Tree Officer if tree protection measures can be put in place for the rest of this area and if the landowner can be asked to re-plant.

Cllr Mrs Podbury advised that EN26 and EN27 have been deleted from TWBC Planning Policies. The Assistant Clerk to ask TWBC about the implications of this and any other policies that have been deleted.

Cllr Mrs Podbury reported that SHLA is now a requirement for new developments of ten or more houses.

Cllr Langridge raised the matter of the planning application on land adjoining 7 Gibbetts, Langton Green. The Assistant Clerk reported that as a result of discussions with TWBC, Town and Country Housing and the applicant this application will not go ahead in its present form. Cllr Hemming advised that the tree adjacent to the Langton Green village sign needs pruning.

The date of the next meeting is proposed as 11<sup>th</sup> September.
