Minutes of the Meeting of the Parish Council held at 7.30pm on Tuesday, 28th September 2004 in the Village Hall

1 Apologies for Absence

2 Minutes of meeting held 20th July 2004

The minutes of the above meeting were approved and signed as a true record.

3 Matters Arising

- a) Costings re remaining funds from Lytchgate project
 - i) Cllr Jones advised that he had spoken to the PCC and there appeared to be no interest in having a flagpole. All agreed this was disappointing and the Chairman suggested Cllr Jones keep the quote on file.
 - ii) The Chairman reported that he had contacted Bolham Lane (Jeanne Wallace) and she saw no problems concerning the village sign. She will help the Chairman complete the application form for 'Non-prescribed traffic signs and special directions'. It was hoped that if the Highways Department agreed to the design and siting, then planning permission would be easier. The mature oak panels could be sourced from Corby Glen and if the project went ahead, the Chairman and Mr Jim Simpson would see to this. **ACTION: D ALLEN**
 - iii) Cllr Goddard commented that the enquiries concerning WREN (who were looking for groups to take up grants for small projects) had not been followed up as there was nothing to ask.

b) Tree Planting to celebrate anniversary of completion of Lytchgate

Discussion followed as to the siting and Cllr Goddard, being the main grass cutter in the churchyard was consulted. It was AGREED to plant a Laburnum in the same position as the previous one. It was felt there was no need for a ceremony and it was AGREED the Chairman purchase the Laburnum and plant it. **ACTION: D ALLEN.**

c) Felled tree at gate to Manor Farm

The Clerk reported there had been no reply to the letter sent to Bassetlaw District Council recording the disappointment at their response and the suggestion that a mature tree be planted instead of a sapling.

d) Surplus Stone at Church

The Clerk advised that Mr and Mrs Allen's cheque for £60 for the stone had been received and paid into the bank.

e) Overgrown hedge on A57

Cllr Ogle believed the hedge had been trimmed, but not sufficiently. It was AGREED to leave the matter on the Agenda.

6 Planning

- i) Location: The Blue Bell Inn, Low Street, East Drayton: *Proposal:* Demolish existing attached two storey house, function room and flat roofed toilet block. (the Chairman having been advised previously no further comments submitted) and:
- Blue Bell Inn, Low Street, East Drayton: *Proposal:* Demolish existing two storey house and function room and erect five dwellings and alter existing access. Notice of Planning Committee Meeting to be held 22.9.04. The Chairman and Cllr Ogle attended the meeting and the Chairman reported that the proposal was largely the same, but shuffled around a little. He said he picked up an element of threat in that Ballard Fort said they had complied with all criticisms raised before and mentioned they could claim costs if they went to another appeal and won. The vote at the meeting was in favour of refusal again. The Chairman was in receipt of a document from Mrs Joyce Small concerning the sale of a parcel of land sold to a previous owner of the Blue Bell which states: (b) not to erect any additional building or erection nor make any alteration or extension to any building without the previous written approval of the Transferor such consent shall not be unreasonably withheld'. The Chairman felt this was a valuable document and wished it to be placed in the Parish records.
- Low House, Low Street, East Drayton: *Proposal:* Erect detached garage (amendment). It was noted a second amendment had been received by the Parish Council and it was understood the garage had had to be turned around. No objections. **ACTION: S PICKARD.**
- iv) Kushti-Tan, North Green, East Drayton: *Proposal:* Erect new storehouse/workshop. The plans were passed around and the Chairman confirmed that no objections had been made to Bassetlaw District Council concerning such a replacement.

7 General business

a) Green Lanes

The Chairman reported there had been concern in Clarborough about trail bikers wanting to use green lanes and he had been in touch with the PC Clerk to offer support. Mr David Strawson had seen the news item in the Retford Times and had written to the Parish Council offering to pay for gates to Back Lane and any other lanes adjoining his land to prevent the problem happening in East Drayton. CCllr Hempsall commented that they were having the same problem in East Markham and they were waiting to see what happened at the next Local Access Forum. His advice was that the best policy for protecting the status of the lanes would be to leave well alone. It was AGREED to reply to Mr Strawson advising him that the Parish Council has considered the situation, but because it is unsure of the legal status of the lane, it cannot be responsible for the blocking of any such lanes. **ACTION: S PICKARD.**

a) Request for gritting side roads

Discussion followed and CCIIr Hempsall urged that a letter be sent to Notts County Council, Mr Bob Hart, at Newark requesting the roads be gritted in the light of the school bus accident that happened last winter. Mention should also be made of various emergency personnel in the village who need to respond in the event of an emergency and must get to the A57. A request that the salt in the bin near the Church gate be replaced or broken up as it is a solid mass. **ACTION: S PICKARD.**

b) Public perception of Parish Council Meetings

The Chairman voiced his concern over the idea that parishioners believed they were not allowed to attend Parish Council meetings. This had come to light recently in connection with the concerns some parishioners had about The Blue Bell Inn planning proposals, when although invited to attend the PC meeting, they did not appear believing it to be a 'closed shop'. CCIIr Hempsall added that other villages were in a similar situation. Discussion followed and it was AGREED to hold the meetings in the main room of the village hall (as had taken place this evening) and the Chairman to produce a circular explaining how the Parish Council ran its meetings. The Chairman agreed to distribute it throughout the village and he also stressed he was keen for parishoners to attend and to use their right to speak at meetings at the given opportunity. **ACTION: D ALLEN.**

c) Rampton Hospital Community Forum Meeting Report

The meeting was held on 26.7.04 and the Chairman and Cllr Ogle attended. It was the Chairman's first Rampton Hospital meeting and he admitted he had been astonished at the statistics. Rampton Hospital costs £85m a year to run. There is one person in the hospital who should not be and he costs the unit £200,000 a year alone. He may be let out on his own, but will require constant supervision. There is planning permission for another 60-bed ladies' unit. A newly constructed unit, supposed to house 70 patients, has only two residents and they are destroying it. The comment was: that at least we are finding out the weak points before the other patients move in. On the positive side, mains gas is going to be supplied into Rampton (not East Drayton). Cllr Ogle added that she was surprised how few people attended the meetings.

8 Meeting adjourned for public discussion.

9 Urgent Business

a) Hot tub cover at Pippins

Cllr Shreeve asked if planning permission was required for such a structure. There is a white cover over the hot tub to maintain heat temperature and it is lit. Several neighbours have concerns. Enquires to be made of Bassetlaw District Council. **ACTION: S Pickard.**

b) Nicholas Hawksmoor

Cllr Ogle presented the tribute to Nicholas Hawksmoor for the Parish Councillors to inspect and it is to be placed in the Church.

c) Sewage problem at Vine Farm

Cllr Goddard enquired as to whether this matter was any nearer being solved. Cllr Ogle replied that it was not, although Severn Trent, Environmental Health, several fellow Parish Councillors, DCllr Isard and Patrick Mercer MP had been consulted, she did not know where to go. CCllr Hempsall AGREED to look into the matter on her behalf and the Chairman requested the item remain on the Agenda for next month's meeting.

10 Date and time of next meeting

Tuesday, 19th October 2004 at 7.30 pm. CCllr Hempsall and Cllrs Ogle and Shreeve sent their apologies in advance.

It was AGREED holding the meeting in the main room had been a success as it created a good atmosphere and although costing a little more to hire, future meetings should be in the larger room. There being no further business, the Chairman thanked everyone for attending and declared the meeting closed at 9.15 pm.
