To reflect the changes to the collection of affiliation fees made by Bowls England:

6 (b) *The Annual Subscription payable by a club to the SBA Treasurer, no later than ~~1st January~~ 7<sup>th</sup> May, (late payment shall incur a penalty charge of up to £100 at the discretion of the ExB) is based on the number of members ~~of that club as at 30th June of the preceding year~~ who have the right to bowl for the current season. A list of ~~the those~~ members shall be provided to the General Secretary by e-mail no later than ~~31st July~~ 7<sup>th</sup> May. ~~The fee to be paid shall be for all members as declared at 30th June, less any member who died after the declaration was made. Should such situation arise a note to that effect shall be included with the cheque sent to the SBA Treasurer. Any members new to bowls or who have transferred from Clubs outside the County after the declaration was made must be added. NB Should a member join a Club from another Club within the County, after 30th~~*

~~June, his/her affiliation fee, paid by his/her former Club shall travel with them. The fee shall not be paid again.~~
