There were no members of the public present.

- 1. **Declarations of Interest**: Personal and Prejudicial: Cllr Mrs Hull on application No. TW/09/03746/FUL/EG1 she resides next door. All Councillors declared a Personal interest in the same application Cllr Mrs Hull is known to all.
- 2. Declarations of Lobbying: There were none.
- 3. Apologies for Absence: Cllr Wheeler (business meeting)
- 4. The Minutes of 19th November 2009 were signed as a correct record.
- 5. Matters Arising: The Clerk had spoken to the Enforcement Officer regarding the Groombridge Farm Shop who said there was nothing to be done while there was a new application pending. He had also spoken to an officer in the Environmental Health Dept who had shown little interest in the selling of meat from a lorry at the site. The Clerk was asked to contact the Enforcement Officer to find out when the proposed resubmission was likely to happen because Councillors were under pressure from local shop owners.

He had contacted the Enforcement Officer regarding the board outside No. 11 Newlands and the owner has said he will take it down.

The Clerk asked the Tree Officer for more information on the issues at Aysgarth Farm and had been sent copies of emails dating back to 2007. It appears that there is no legal requirement for the owners to remove the conifer trees. It was decided to write to the owners direct and ask them to remove them. *The Clerk will liaise with ClIr Mrs Podbury.*
