Decision: Remain neutral – leave to Planning Officer

Comments: Concern expressed that the proposed side extension is too close to the boundary with No. 5 St Mary's Lane and that this boundary is an established hedge, including a tree, which would be at risk of damage. The proposed front porch would be too close to the road and out of keeping with the street scene. The significant boundary hedges have not been shown on the drawings. The proposed roof lights are out of keeping with other properties in the vicinity.
