4.0 Public involvement session: (Agenda Items only) - The road surface on the road up to The Tower House was reported as very poor. Cllr Motley to report to Highways.

- **6.0 Matters Arising** Members were asked to receive any updates from the minutes of 2nd April 2019 not included elsewhere on the agenda:
 - **6.1** (Agenda Item 5.5) Cllr Alderson reported that some potholes had been repaired but many were still outstanding). At Seifton Batch it had been reported that workmen had been instructed to repair the worst six. Seifton Lane potholes had not been attended to yet. Cllr Motley to add to those at Burley to report.
 - **6.2** Cllr Steele reported that the other side of Seifton Bridge had now been repaired.

- **6.3** Burley- Cllr Steel read out email response from Ffion Horton. The vulnerable area in Burley has been added to the Council road register (gazetter) forewarning anyone working in the area to take specific care.
- **6.4** Kier have been advised regarding concern with the quality of grass cutting in the past.

7.0 Reports from Members

Cllr Motley gave her annual report.

- A generally frustrating year in being able to progress council business as funding streams and response from government very slow as their attention elsewhere.
- Elderly Care at risk due to the lack of response to the Green paper
- Roads another example of bad financial planning though general agreement now that rural areas need more funding.
- Council is only able to borrow money for revenue projects therefore non revenue projects are on hold, although some plans where money can be borrowed are making progress, for example, the Shopping Centre and setting up a Housing company, run by Shropshire Council.
- The Scrutiny Committee is currently looking at Youth Services as a result of young people from market towns reportedly being dragged into organised crime and a general increase in knife crime in cities.
- Local Joint committees are stagnant at the moment but may re-emerge
- A recent group meeting looking at problems over the year addressing potholes
- Concern that the removal of Bring Banks will increase fly tipping.
- The prospect of further reduction in Public Transport has caused outrage as contributes significantly to rural isolation.
- A success for The Rural Services Network whose template on the Rural Economy has been used in the recent House of Lords report into the 'challenges and constraints facing the rural economy and how they can be addressed'
- A further meeting with Liz Truss

Cllr Turley reported a Bridge in Siefton Lane on public footpath had a rotten plank which needed replacing. Report to Gary.
