Agenda Policy

1. GE Planning application

Committee debated the merits of recommending a course of action to Council regarding HPC's position regarding the playing pitch mitigation strategy on the basis that urgent works were needed to the Pavilion that had already been delayed and in the light of this HPC needs to formally agree how it will go forward. The Clerk was asked to approach EBC to understand what they understood the situation to be before deciding.

2. MDL special hearing

The chair outlined the key aspects of the hearing which was held virtually. MDL continued to argue that for the investment in the marina and leisure provision to be feasible, that residential development was needed to fund it. The hearing focused on agreeing a Statement of Common Ground (SoCG). EBC stated that their reserve position was that the policy should be withdrawn but did agree a range of issues that formed part of the SoCG and would be subject to consultation as part of the Inspector modifications.

3. Mercury Bund

The Chair took the Committee through a short presentation which showed the access to and the Mercury Bund as well as the history of the site and access to it. This helped to contextualise the discussion as it was not a location that all members had been too. This included the discussions that had taken place with MDL for HPC to take over the site and allow public access. The Committee shared many of the concerns expressed by the community and it was agreed that a letter should be sent to MDL to set out those

Clerk confirmed that following the Newsletter article there had been three objections and on that basis there would be a recommendation to Asset Management Committee to agree to a trial closure from April to September.

5. Footpath 1 and HCC

HCC had contacted the Office requesting information about our priorities for Footpath 1 is developers' contributions were coming forward. Cllr Underdown and the Head Groundsman met with the HCC officer and highlighted the key issues with the path and suggestions about it being substantially improved. They were informed that the contribution would be coming from the proposed housing development in Satchell Lane if given planning permission.

6. Mallards Moor

Committee was updated on the recent issues of trial bikes on the Moor and through the woodland. Now that the parish boundaries have changed this area now forms part of the Parish and similar issues could be a feature in the future.
