Residents of Brough are uncertain as to why the chapel is being closed. No one knew who the minister is. Everyone was keen to see it continue as it was, especially as it is understood that it paid for itself. Everyone wanted to try and find out what might be happening with it. This is the only community building for use by the residents of Brough. It was thought a good idea for those members of the community present, to try and find out if everyone within the community would like to maintain this building for community use in the future.

There was a query about the condition of the post box near the One Stop, which is in a very poor condition. This has been reported a number of times over the last 3 years and is chased on a regular basis with the Post Office. 63 – Letter to Ursula Lidbetter prompted a meeting to discuss the Royal Oak with Ms Lidbetter and a member of the estates department on 30 May 2017

Attending on behalf of the Parish Council were Rosie Scott, Chris Allen and Michael Davies to discuss LCS proposals for development of the Royal Oak.

The LCS are considering developing the Royal Oak site for housing by building a 3-bed home in the car park area and converting the pub into 4-bed dwelling or possibly apartments.

Parish Councillors pointed out that Collingham already has many 3 and 4 bedroom homes which are not selling and that low cost, smaller homes would be more appropriate.

The LCS agreed to look into converting the site to two bed apartments and maybe affordable and smaller units, ensuring there would be sufficient parking spaces to accommodate residents. Possibly small garden areas could be incorporated.

The LCS wishes to move quickly unless there is a “fantastic” idea for the pub (gastro-pub was not considered) because they did not want the site to become derelict, which will attract all sorts of problems.

Councillor Jim Barrie has since found an article in CAMRA magazine which states that legislation will come into force at the end of July to give councils and communities greater powers to stop developers closing or demolishing pubs. Nine companies, including the Co-Op, have agreed to respect the spirit of the legislation until the new rules are introduced.
