Unfortunately, none of the officers attended. The Clerk has contacted the relevant officer again.

# 13. TOWN AND PARISH COUNCILS BOUNDARY REVIEW

The following message has been received from the Shropshire ALC.

"As you will be aware, it was announced early in 2021 that Shropshire Council was planning to undertake a Community Governance Review throughout Shropshire following the Local Government Elections held in May 2021. At that point, representations were initially sought from Parish and Town Councils on changes that might be considered to be less controversial in nature and which had some element of support from the local community and surrounding parishes. Changes were to be effective from the date of Local Government Elections scheduled to be held in May 2025. It was anticipated that a programme for the review would be announced later that year. However plans were halted at the request of the Local Government Boundary Commission for England when it announced, in August 2021, that it would be undertaking a review of divisional boundaries (Unitary Council Wards), initial consultations for which commenced in December 2021. Since then, Parish and Town Councils have still been encouraged to continue to consult with neighbouring councils and submit their wishes, with or without any agreement, and submissions were collated by SALC and passed on to Shropshire Council. The position now is that the LGBCE has set out its proposed boundary changes and more information and details can be viewed here - <u>https://www.lgbce.org.uk/all-</u>

reviews/shropshire . An interactive map is here - www.lgbce.org.uk/all-

<u>reviews/shropshire</u>. The changes become law once Parliament has approved them with new arrangements in place for the Shropshire Council elections in May 2025. As a result of this, Shropshire Council will need to have in place arrangements for those divisions, wards and parishes affected by the changes and this will include a review of Polling Districts. Work on this would prevent a full Community Governance Review taking place which would also take 12 months to complete.

However, it would be practical to undertake a review of those wards and parishes that are directly affected by the divisional boundary reviews. If you fall into these categories, you will be encouraged by Shropshire Council to submit your requirements so that these can be taken into account.

Expressions of interest already submitted, unless they fall into the categories described above may not be considered until after the 2025 elections. This may be disappointing, however, the Divisional Boundary Review and the subsequent arrangements for the 2025 elections must take precedence.

It is currently expected that a Community Governance Review of the whole of the area will commence shortly after the ordinary elections in 2025."
