MINUTES: of the Meeting of the Council held at Seamer & Irton War Memorial Hall,

Main Street, Seamer, Scarborough, YO12 4QD on 12 April 2022

commencing at 7.00pm.

1 APOLOGIES FOR ABSENCE

RESOLVED that:

- (a) apologies for absence given in advance of the meeting by Councillor H Mallory be received.
- (b) the previously circulated reasons given for absence by Councillor Mallory be approved.

2 DECLARATIONS OF INTEREST

RESOLVED that it be noted:

- (a) no declaration of interest not already declared under the Council's Code of Conduct or Members' Register of Disclosable Pecuniary Interests was received.
- (b) no application for dispensation from restrictions on participation in discussion and/or voting was received.

3 PUBLIC PARTICIPATION

The following matters were raised by Councillors on behalf of a members of the public:

- (a) Fences of 2 properties, backing on to Scarborough Road, Seamer, which were erected outside the boundary wall and were not in keeping with neighbouring fences.
- (b) Continued absence of the waste bin and seat on Stoney Haggs Road.

 Councillor Stockdale declared a pecuniary interest in and did not participate in discussion of this matter.
- (c) Sequencing of the green filter arrow on the traffic lights on the B1261, approaching from Crossgates to turn right into Stoney Haggs Road.
- (d) Rutts in the verges on Seamer Moor Lane, especially approaching the junction with the A170 Racecourse Road / Stepney Road.
- (e) Absence of warning signage to alert traffic and protect users of Seamer Pre-School.
- (f) Continued lack of waste bins in Pasture Lane, beyond Long Lane, to and beyond Chew Lane, and dog faeces not picked up, or bagged and thrown onto neighbouring properties by owners. Councillor Stockdale declared a personal interest in this matter.
- (g) Continued absence of the memorial plaque on the bench at Crossgates roundabout.

- (i) Councillor Jeffels' offer to raise the issue of the fences of 2 properties, backing on to Scarborough Road, Seamer, which were erected on the pavement side of the boundary wall with whichever of the County or Borough Council owned the land, be accepted with thanks.
- (ii) further to minutes 19 of 4 May 2021 and 92 of 9 November 2021, the clerk be delegated to consider a quotation requested from Creating Solutions Ltd to replace the legs in keeping with the Council's other benches, and refurbish and reinstall the bench on Stoney Haggs Road, in consultation with the Chairman and Vice-Chairman.
- (iii) further to minute 115 of 9 March 2021, the Borough Council then be re-requested to install the replacement waste bin on Stoney Haggs Road.
- (iv) further to minute 10(e) of 14 December 2021, Councillor Jeffels' offer to raise the sequencing of the green filter arrow on the traffic lights on the B1261, approaching from Crossgates to turn right into Stoney Haggs Road, with the County Council's Highways Customer Communications Officer, be accepted with thanks.

- (v) it be noted the County Council had advised no action could be taken concerning rutts in the verges on Seamer Moor Lane but the situation would be monitored.
- (vi) Councillor Jeffels' offer to raise the issue of signage to alert traffic and protect users of Seamer Pre-School be accepted with thanks.
- (vii) further to minutes 86(iii) of 13 August 2019 and 89(e)(iii) of 9 November 2021, the Borough Council be re-requested to install waste bins in Pasture Lane beyond Long Lane, to and beyond Chew Lane, along with signage and patrols by Dog Wardens.
- (viii) concerning the memorial plaque on the bench at Crossgates roundabout:
 - (1) Councillor Stockdale's offer to provide the original memorial plaque to the clerk be accepted with thanks.
 - (2) a replacement then be purchased and installed.

4 MINUTES

RESOLVED that the previously circulated minutes of the meeting of the Council held on 8 March 2022:

- (a) be amended in minute 149 to:
 - insert a colon and new paragraph (i) with the existing wording "it be noted:" after "RESOLVED that".
 - (ii) re-number the existing paragraphs (i)-(iii) as sub-paragraphs (1)-(3).
 - (iii) delete the second comma and the words "each under delegation" in paragraph (iii) [new sub-paragraph (3)].
 - (iv) insert a new paragraph (ii) "under Financial Regulation 4.4, a further £8,650 of reserves be earmarked and committed to the Play Equipment Inspection/Repairs budget (£10,650 less £2,000 Borough Councillor's Locality Budget confirmed commitment)."
- (b) be amended in minute 151(ii) to delete the word "duly".
- (c) then be approved as a correct record and signed by the Chairman.

5 JUBILEE ALLOTMENTS

(a) Matters resolved under delegation

Further to Financial Regulation 4.1 d) & Standing Orders 15(b)(xviii)-(xx), the Council considered a report by the clerk of matters resolved under delegation since the last meeting. RESOLVED that:

- (i) the report be received.
- (ii) the following decisions taken under Standing Order 15(b)(xix), in consultation with the Members of the Allotments Working Group and then the Chairman & Vice-Chairman, be noted:
 - (1) a 8' x 6' x maximum 6' high greenhouse on a plot be approved, subject to a requirement to position the greenhouse not to overshadow any neighbouring plot.
 - (2) a poly tunnel of height 200cm x width 200cm x length 300cm on a half plot be approved, subject to a requirement to position the poly tunnel not to overshadow any neighbouring plot.
 - (3) a 6' x 4' x maximum 2m high shed on a half plot be approved, subject to requirements to position the shed adjacent to the field boundary and not to overshadow any neighbouring plot.
 - (4) the replacement of an existing shed on half plot be approved, subject to requirements the replacement be the same size or smaller and in the same position.

(b) Tenants' Participation

6 HIGHWAYS

(a) Inconsiderate driving and parking in Pasture Lane, Dennyson Avenue, Bell Close and Eastgate, causing risk to children going to and from Seamer & Irton Community Primary School and inconvenience to residents

The Council considered a verbal report by Councillor Stockdale.

RESOLVED that:

- (i) it be noted with thanks the Police had been active concerning inconsiderate driving and parking in Pasture Lane on 8 April 2022.
- (ii) further to minute 140(a)(ii)(2) of the last meeting, this matter be deferred to a future meeting for enquiries to be made by the clerk concerning options for funding, and alternative cycling and walking access to the school.

(b) Heavy Goods Vehicles inappropriately using Pasture Lane and Chew Lane

RESOLVED that, further to minute 140(b) of the last meeting, it be noted images of the vehicles stuck in Chew Lane, on or about 28 December 2021 and 22 January 2022, had been provided to assist the County Council in seeking to recover the costs of verge repairs.

(c) Pasture Lane: Carriageway Height and Ruts

RESOLVED that, further to minute 140(c) of the last meeting, it be noted the County Council reported it did not have the funding to re-profile the verges in Pasture Lane to allow easier use by pedestrians and wheelchairs or pushchairs.

(d) Vehicle Activated Signs (VAS)

RESOLVED that, further to minute 140(e) of the last meeting, it be noted:

- (i) installation of most of the equipment had been completed on 8 April 2022.
- (ii) the installation at Lighting column number 3 on B1261 Ayton Road, Irton could not be made due to damage to the lighting column, details of which would be provided to the County Council to repair or replace the lighting column, prior to installation.

(e) Community Speed Watch (CSW)

Further to minute 140(f) of the last meeting, the Council considered a report by the clerk. RESOLVED that:

- (i) the approved areas and assessed, recommended sites for Community Speed Watch be noted, as follows:
 - (1) approaching the first house on Centurion Way, from the B1261.
 - (2) both ways, near and opposite the stone bus shelter, on the B1261 between Musham Bank and the Byways roundabouts.
 - (3) both ways, from the brick bus shelter / start of the path and top of the steps down under the bridge, on the B1261, Station Road / Cayton Low Road, between Byward Drive and the railway/A64 bridge.
 - (4) approaching from Seamer on the B1261, near Crab Lane and Rowan Fields.
- (ii) the limited availability and likely shared use of Police equipment between groups of Community Speed Watch volunteers in different Council areas be noted.
- (iii) the Council consider purchasing a set of equipment for the exclusive use of the local Community Speed Watch volunteers under Item 15 of this meeting.

(f) Overgrowing of the footpath on the east side of the B1261 from Musham Bank to the Byways roundabout

Further to minute 9(d)(ii) of the meeting of Council Members held on 11 January 2022, the Council considered a verbal report by the clerk.

- (i) it be noted the County Council:
 - (1) had not given consent to the Parish Council engaging its Grounds Maintenance Contractor to clear the overgrown grass etc from the footpath.
 - (2) would require any works, if agreed, to be undertaken by a contractor authorised to work on the highway under the County Council's provider list(s).
 - (3) advised there was no pin kerb edging to the pavement and a sample section checked by a Traffic Officer indicated deterioration of the pavement surface and/or edging under the overgrown grass etc.
- (ii) the need to resolve the repair of the pavement surface and/or edging, if exposed, with the County Council be noted.

- (iii) Councillor Stockdale's offer to provide details of a suitable contractor to clear the overgrown grass etc from the footpath to the clerk be accepted with thanks.
- (iv) the potential contractor be checked against the County Council's approved provider list(s).
- (v) quotations then be sought from County Council approved providers.

(g) Flooding at the eastbound B1261 entry from Seamer to the Byways roundabout

Further to minute 45(b) of 14 September 2021, the Council considered a verbal report by the clerk.

RESOLVED that:

- (i) further to minute 140(d) of the last meeting, it be noted the County Council had hoped its specialist contractor could start further investigation and remedial work, to resolve the apparent obstruction or collapse in the drain causing the recurrent flooding, whilst the temporary 4 way traffic lights were in place for the recent works to extend the pavement and install the dropped kerb on the Byways side of B1261 Station Road.
- (ii) the estimated timescale to undertake the investigations and remedial drainage works be sought from the County Council.
- (iii) the safe positioning of signage, warning of forthcoming works, be further raised with the County Council.

 - (2) on Saturday 4 June 2022:
 - (a) a family party from 12.00 noon with a bouncy castle and games, and live music from 8.00pm at The Mayfield, Seamer.
 - (b) a family fun day from 12.00 noon with stalls, children's games, live music and a barbeque at the Copper Horse, Seamer.
 - (c) a family event with a band, barbeque and a bouncy castle in the afternoon at Seamer Sports Association.
 - (3) on Sunday 5 June 2022 a 'big lunch' at The Mayfield, Seamer.
