Re: Proposed application under section 116, Highways Act 1980 Highway at The Castle, Brookwater, Donhead St Andrew

I refer to the two sections of highway shown cross-hatched on the enclosed plan and advise that Wiltshire Council has received a request to apply to the magistrates' court to extinguish or stop up the highway rights running over these areas. The request has come from Mr and Mrs Hay of The Castle and the Area Highway Engineer is satisfied, in principle, that the areas concerned are unnecessary for public use or any other highway-related purpose. This is the statutory criterion which must be applied to such requests.

I would be grateful, if possible, if this request could be discussed at the parish council meeting on 12 January 2018. If you have any queries regarding the proposal, please contact me. Otherwise, please complete and return the enclosed form to let me know whether the parish council consents to the proposed application. If you do not consent, please let me have a full statement of your reasons. I will similarly consult Councillor Tony Deane, as Wiltshire Council member for the area.

If you consent, I will prepare a report for Cllr Bridget Wayman, Wiltshire Council's Cabinet Member for Highways, Transport and Waste. She will then decide whether the Council should proceed with the proposed application. I will of course keep you informed.



# Proposed application to stop up highway at The Castle, Brookwater, Donhead St Andrew, SP7 9LG.

### Section 116, Highways Act 1980

Areas of highway proposed to be stopped up are shown edged and cross hatched black. Parcel 1: approximately 22.4 metres at the road frontage and 24.5 at the rear, tapering from 0 to 9.7 metres from west to east.

Parcel 2: approximately 16.6 metres at the road frontage by 5.4 metres in depth at the western end and 13.8 metres at the eastern end.
