Address: Land Adjacent To Sallins Cottage, Picklescott, Shrewsbury, Shropshire
Proposal: Erection of a steel portal framed building to house the livestock as well as machinery and equipment
Following the site visit on 14 February and discussion it was **AGREED** that the Parish Council cannot support this application as it is too near Sallins Cottage and there is a more appropriate site which has already been suggested
