MINUTES OF HORSMONDEN PARISH COUNCIL PLANNING MEETING HELD IN HORSMONDEN VILLAGE HALL, HORSMONDEN AT 7.30 P.M. ON 29th APRIL 2015

Present: Cllr Davis (Acting Chair), Cllrs Isaacs, Stevens, Russell, Stanton, Hughes.

In attendance: Clerk (Lucy Noakes), 3 members of the public present.

Declarations of Interest: Declarations of pecuniary and non-pecuniary interests in accordance with the Code of Conduct were invited, none were recorded.

As Cllr March was unable to attend the meeting, an Acting chair was required. Cllr Hughes proposed that Cllr Davis should act as Chair, seconded by Cllr Stanton. Unanimous.

1. APOLOGIES FOR ABSENCE

Cllr March -Canvassing in Wales.

Cllr Lawrence - at a work related meeting.

It was proposed from the Chair that these reasons be accepted as reasonable under the circumstances. Unanimous.

2. PUBLIC SESSION

Mrs Parker had requested to speak about item 3.2 - Proposed diversion of footpath WT347 at Horsmonden – Lewis Heath, as this matter affected her property. Mrs Parker had made an application to alter the route of the footpath approximately two years ago, however this matter was now being looked at by KCC Public Rights of Way to see if the changes should be made. Mrs Parker said that until the 1980's most people assumed the footpath took the route along the road past their house, Hill Top, Lewes Heath. However the owners of Hazel Street Farm discovered that the ordinance survey map and definitive maps differed with regards to the footpath route and asked to have the footpath moved back to its position as shown on the definitive map, taking it through Mrs Parker's garden.

The proposal being looked at by Kent Public Rights of Way, requests that the footpath is moved back to the route following the farm road, rather than through Mrs Parker's garden. This move would also divert the footpath away from the garden of Lewes Heath House.

3. PLANNING

Cllr Davis proposed that item 3.2 be moved forward so that Mrs Parker could listen to the discussion and that this then be followed by a discussion of application TW/15/502574/FULL as Mr and Mrs Beale the owners were present and wished to hear the discussion. Unanimous.

3.2 Proposed diversion of footpath WT347 at Horsmonden - Lewis Heath

After a brief discussion and a look at the maps provided, Cllr Stevens proposed that the Parish Council accept the alteration as a sensible new route and on grounds of security. This was seconded by Cllr Isaacs, unanimous.
