Councillor Sam Smith – Petition to repair Main Street, Balderton, to confirmed it will be resurfaced, but no date yet. Weeds on Poets Corners – escalated complaint. School Drop-off point Chute Ede, Primary School a cost of £5000,00 to bury Virgin and BT cables. Cllr Smith explained that LSC Grants are now available, however a very short deadline 7th November 2025. Cllr Sam Smith offered his support for any application made by Balderton Parish Council, Cllr Keith Girling also offered his support. Councillor Smith also wanted to update everyone about the plaque in honour of Sir Frank Whittle in Main Street, Balderton where he was a resident while designing the jet engine, however, as Cllr Elson was not present, he will liaise with her and come back on this matter at a later date.

Councillor Keith Girling – Weed spraying completed today – London Road, Balderton

Received a request to resurface a section of London Road – Highfields School to Al Chip Shop

Councillor Jean Hall – Continuing to work with Grow Balderton, there have been issues with water to the site, however we are confident that this is now sorted with the Water Supply Companies. Footpath Eleven (Meads Ways to Sustrans, through old Flowserve site. is closed and due to re-open on 28th November 2025.
