Public Participation and Presentations - Questions and/or statements 2015.11.03

> Merton: The immediate neighbours (Mr and Mrs Sykes) raised a number of points relating to the application:

- a. The proposal to relocate the RoW (as indicated on the application plans) had not yet been discussed.
- b. The proposed splay appeared to have less depth than the original, but it should have sufficient depth to allow any cars to park fully off the road when entering the gated driveway.
- c. The living room window nearest the south-west corner of the extension may overlook windows in the neighbouring property (on the south elevation).

Roosters: The applicants highlighted the main aspects of the application; being:

- a. The log cabins were designed as luxurious holiday lets that would bring employment to the local area and also benefit the local pub and post office / shop.
- b. No neighbouring properties would be in the sight-lines from the chalets and vice-
- c. The applicants would be living within the immediate area and would not tolerate any bad behaviour/noise.

Each P.Cnllr spoke in turn, supporting the application but making the following points:

- a. The applicant and neighbours should work together to agree the proposed
- access/right of way.
- b. The Highways section be asked to satisfy themselves that the proposed access is compliant with relevant guidelines for Highway safety. The position of the proposed access to and from the property was thought to be safer.
- c. Parking provision on the site is adequate for visitors.
- d. There appears to be an issue with a window in the living room overlooking the neighbouring property.

P.Cnllrs resolved to support the application making note of the above points.
