Members of the Public:

Jean Jarvis CEO South Shropshire Furniture Scheme and Chris Boote a Volunteer Trustee for the South Shropshire Furniture Scheme gave a presentation on the grant application submitted in respect of CASCA. The Furniture Scheme recognise the importance of the Community Centre as a Community Asset and has the appetite to continue with the management of the centre over the next five-year period but will require financial support and a longer-term partnership form the Town Council.

Income to the Community Centre has reduced by approximately £45,000 due to withdrawal of funding from Shropshire Council and although cuts have been made mainly to staffing costs there will still be a shortfall in the year 2017/18 and therefore the South Shropshire Furniture Scheme are seeking a revenue support grant of $\pounds 12,000$ from the Town Council.

The Council will respond to the consultation supporting no charge for car parking in Craven Arms and to raise objection to the proposed withdrawal of the free fifteenminute parking and the extension of the period of car parking charges from 6pm to 8pm in the various Town Areas throughout Shropshire.
- c) The Town Council noted that there would shortly be a consultation on library services within Shropshire.
