Chairman Cast welcomed the Members of the Public as well as the councillors present.

A member of the public stated that he had received a reply to his FOI request. He reported that one of the cameras had been taken down at the ponds. He wondered when permission was given and if the current Parish Council approved of the cameras. Another member of the public stated that in 2011 she had explained to the council how they were nature rather than surveillance cameras.

She continued to say that the Apple trees in the orchard would need to be moved during the next few months and that the Inland Drainage board had been to clear sections of dyke.

The minutes of Bleasby Parish Council meeting held on Monday, 14 September 2015 were received and approved to be signed as a true record.

- BPC15-40 To receive updates resulting from the previous meeting's minutes: The clerk reported she had not yet written to the owners of the pub.
- BPC15-41 To receive a report from the County and District Councillors.

 County Cllr Jackson reported that the speed tube tests had completed recorded speeds had met intervention levels for the introduction of a Permanent Interactive Speed Sign, and as such this location had been added to the list for consideration and funding. He pointed out that this did not automatically mean that signs would be funded.

 The state of the Parish's footpath between the level crossing and Goverton was being assessed.

A new company, Cormac, would be taking over the maintenance of the County's roads in Spring. It was hoped that this would improve the quality of work received. Several potholes had been reported.

District Cllr Blaney reported that the Local Plan Core Strategy was currently under review. He explained that the Council was currently investigating changes to spatial strategy 3 which would impact on any potential development in the parish. He reported that currently it was unlikely that any significant new building would take place in Bleasby as it has SP3 status with insufficient facilities and identified as an unsustainable village. Also under review would be the provision of Gypsy and Traveller sites. He reported that the District Council was set to move to new premises which would be joint use with other agencies and cheaper to run than Kelham Hall.

- BPC15-42 To receive update on banking arrangements and resolve to adjourn meeting allowing for paperwork to be signed.

 The Clerk informed the Council that the forms to enable the changeover of banking would need to be signed and councillors would need to fill in their personal details. The meeting was briefly adjourned whilst the paperwork was being completed.

Cllr Goodwin proposed seconded by Cllr Horsley to support the application. The proposal was rejected with a majority vote and planning permission was therefore not supported.

BPC15-49 To consider Autumn/Winter events on the Glebe Field and winter availability of the school field- Deferred from previous meeting.

The Council agreed to purchase a Christmas Tree as in previous years and the PCC may organise its own event on 19th December.

It was considered to have an official lights' switch-on following the end of the School's Christmas Fayre on 5th December. **Clir Horsley agreed to organise the Christmas tree purchasing and the "light switching on" event.**

Cllr Gent reported that the school field could be opened over the winter months at an extra cost of $\pounds 50$ if written agreement could be obtained from the head teacher. The Council agreed to finance this for the benefit of the children in the village if consent could be obtained.
