## Section 106 contributions

No schemes had been put forward by Councillors following a request for information at the March meeting of full Council. Agreed that a new bench to commemorate the Platinum Jubilee is submitted, to be placed on the open area at the junction of Portway and Woodlands Road at its most southerly junction. In Open Forum, Borough Councillor Frost explained the differences between \$106 and the Community Infrastructure Levy.

# Tree survey

The current survey is not yet complete, with approximately 25% of the trees still not surveyed. it is agreed that the surveyor who carried out the surveys in 2016 and 2017 is asked to look at what is required and provide a quotation for the completion of the works, including the handling and organisation of the remainder of the project (tenders to contractors, management of their works, etc). Also agreed that a meeting should be organised with the current surveyor.

Once completed, consideration to be given to a replanting scheme. Also noted that encroachment by bramble and nettle is increasing in our open areas.

## Speed Limit Reminder

Thanks had been made to the resident who had helped with the provision of the mounting plates for the Speed Indicator Device, and a 'Good Citizen' certificate provided, in black and white. This machine has been in use, mainly on Baughurst Road. A request had been made for coverage along Wolverton Road, in the urban area. The Autospeedwatch machine had also been in use, although has intermittent problems with internet coverage which needs to be resolved. Repeat offenders exceeding 60mph in a 30mph limit will be notified and reported to the Police.

# Weekly inspections

Weekly inspections are carried out by Cllr Cockle for Wolverton field, and the maintenance contractor for Long Grove, and are recorded.

# Tarmac paths

Agreed that the lowest quotation of £2,980.00 + VAT is accepted. The contractor has agreed to cut out and replace an offending area of path where a small section of weeds are coming through.

#### War Memorial

Clerk had requested advice for its repair (failing limestone mortar crack) from the War Memorials Trust, who have advised that the Memorial does need monitoring, and that repairs will eventually need to be carried out. The Clerk has further asked whom should carry out the monitoring, but no response received as yet. As the land on which it sits belongs to this Council, but is not registered, it is agreed that this is added to the list for HCC to investigate, at a top cost of £200.

#### Defibrillator

This still on order, but no sign of delivery of it, or the cabinet, as yet. Wolverton Hall have approved the quotation for electrical works to be carried out in connection with the machine, but have indicated they do not wish to proceed further until the unit has arrived.

Excellent cakes, with tea and coffee, were provided by the WI, Trefoil Guild and Heath End Hall committee, whilst watching the entertainment provided throughout the afternoon. This included Dancephaze, U3A Guitar and Ukele groups, and Rock Choir Newbury. There were also stalls by Baughurst Scout and Guide Group, and Messy Play with Jo Rhoades-Walkley. All profits will go to charity.

In the evening, the Hall provided free screening of the 'Party at the Palace' on the big screen, with a hog roast as part of the proceedings, and Sunday saw a Service of Thanksgiving at St Stephen's church in Baughurst, in the presence of the Deputy Mayor and Mayoress of Basingstoke and Deane, Cllr David Leeks and his wife, Amanda. ## 194. Appendix 1

County, Borough, DAPTC and Police reports

- a) County Councillor D Mellor reported:
- Although the County Council has no elections until 2025, the decision of the long time leader, Keith Mans, to step down has led to some Cabinet restructuring and subsequent changes. I still have 3 years to go until the next election and in addition to being the Councillor, I also have the Chair of the Economy, Transport and Environment Select Committee and Chair of Governance on the HIOW Fire Authority to attend to. Tom Thacker and self also sit on the Hampshire Pension Fund Board.
- Ukrainian Update the VISA problems have largely dissipated and arrivals continue-c.2500 of the c63000 arrivals in the UK have headed to Hampshire at a time when we have not yet dispatched some of the Afghans who arrived last Autumn. Still, the Ukrainians are settling quickly, well financed etc and pleased to report that we have already some working in the hospitality sector at a nearby golf course. No problems with schooling although this being monitored closely with the new school year entrants in September. Additional facilities such as free School Meals, settlement grants, even short term bus travel being made to ensure they settle in. should the Parish feel they have enough Ukraine visitors to warrant some dedicated local authority expenditure as we have now in a few areas, then HCC does have funds to disperse to develop the local community.
- Grants the County Councillor Grant Scheme is now open and already approvals pending in the Parish. I have to say that this is not just to assist in the operating costs of say a Village Hall; it is paramount for new projects and I make no apology for focussing on the youth with my funds. Purchase of sports kit etc being one example of supporting a charitable cause. On a bigger scale and considering that there are many less fortunate suffering in the current financial situation, HCC is party to the Household Support Fund to assist those with real problems on energy bills although to date this does not include Liquid Gas or Oil. HCC is working with Citizens Advice in respect of hardship monies and also with the schools directly.
- On the subject of Energy, if there are any community projects developing energy, then there are now Grants for this under the Climate Change banner.
- Consultations; I would repeat the invitation for the Parish Council to respond to the consultations on ''HCC's Local transport Plan 4 '' currently on the website through June/July as

this set out the plans for the 2029 to 2050 period. The eco warriors dominate. One area I continue to be annoyed about is the slow progress in respect of the North South Road Connectivity programme which started over two years ago with input from West Berks, Reading BC, HCC and Basingstoke. Of course, COVID has not helped, but the lack of certainty over housing plans- be they e.g at Manydown off the A339 or on the A33 at Sherfield on Loddon, at M3/J7 what with new hospital plans, at West Berks with Sandleford and the moves along the A33 into Reading has stalled any effort. Of course draft ideas for a station in Oakley which would prevent road construction to a certain extent, the current developments on the A34 etc mean a lot has to be considered. I had to fight hard to get the A339 area included in the programme and hope to resume battle shortly.

- Hampshire Libraries has been celebrated for all its efforts during COVID- phenomenal response
  to the E Library operation and its other innovations.
- The usual big ticket items- Adult Social Care and Children's services continue to perform and be rated very highly nationally.
- Attending a Fire Authority training night at Kingsclere I was taken to task by the North Hampshire Commander re the lack of checking undertaken by the public in respect of smoke alarms. A good deal of what the Fire and Rescue Service undertakes is fire prevention- a solid investment with a good return- and the public should use it accordingly.
- The speeding review continues with data capture; input from other authorities; evidence gathering and now an online consultation. Expect some recommendation in September/October.
- Jubilee weekend appears to have been a great success across the County; nothing tastes better than Government funded food and wine!
- An update at the meeting: new roof at Bishopswood School; recruitment continues for social
  workers; No 2 bus route likely to survive recent review; working towards electrification of small
  buses; updating website; road repair budget exhausted; and County Deal (between
  Portsmouth and Southampton) inching forwards.

## b) Borough Councillor K Morrow

• Introduced himself, and advised that he will be sitting on the Community and Environment Partnerships Committee and a sub on the Development Control Committee

## c) Borough Councillor S Frost

• Gave a comprehensive overview of Draft Local Plan, and the impact it has on local planning issues. The Draft Plan is nearing completion, and will soon be out for consultation. The guidelines from central government currently ask for 17,820 new houses over a 5 year period, which will need to be met. Once the Local Plan is ratified, there is a process to go through, but BDBC officers may use the Plan and its contents with regard to planning applications.
