- a) The Clerk reported that Shropshire Council had undertaken a survey of the Bridge Caynham Road Ashford Carbonell and the report did highlight some works that were required of a non-urgent nature to the blockwork in the flood arches which will be undertaken in the next financial year if budget constraints allow.  
The structure is generally weathered with some extensive weathering to individual sandstone blocks and spalling bricks to parapet but remains in a fair condition.
- b) The Clerk to enquire with Shropshire Council when the damaged Kerb stones are to be replaced at the Village Green.
- c) The Clerk to enquire with Shropshire Council about the cost of an additional Litter/Dog Fouling Bin to be provided in the middle of the village.
- d) On behalf of the Parish Council Mr D Brundrett will continue liaison with the grass cutting contractor for the cutting of the amenity areas in the village.
