So, it needs to be determined exactly what was undertaken and the outcome- (to do Clerk-MP)

-Paving Slabs to notice board Ref. 103311075; Clerk-MP received email from Johnny Davis to say that Mr. Fox was permitted to create a footpath up to the Notice Board. He also attached what he thought was Utility Plans indicating important underground works. This was forwarded to Mr. Fox but on re-examination of email from Johnny Davis the attachment was 'blank'. Mr. Fox would now like to plan the work related to the footpath so a resend of the attachment has been requested from Johnny Davis (New Ref. 3136173
