- **1. Apologies for Absence:** There were none.

The Clerk reported that he had been in telephone contact with Maureen Berry of Craigmore, Barrow Lane regarding WT111 and she confirmed that the land was owned by the Berry Trust and that she and her husband were responsible for the footpath. They would be looking in to the matter as early as possible.

7. Items for Information

Cllr Langridge had been contacted by a resident of Ironstones regarding the use of the address of Holmewood Gardens The Boundary Langton Green TN4 8RP being used for the Middlefield development. The Clerk had made some enquiries and confirmed that the address is NOT going to be used. The roads have been named as follows

Colbran Way Langton Green Tunbridge Wells TN3 0BF

Redland Avenue Tunbridge Wells TN4 8AJ

Cottington Drive Tunbridge Wells TN4 8BF

Middlefield Court Tunbridge Wells TN4 8RP

First of all TWBC does NOT allocate post codes. This is done by the Royal Mail which does not recognise Parish Boundaries. Debbie Larkin has appealed to RM saying that this will lead to confusion but they have not changed their mind. (It should be noted that there are areas of Goudhurst that are in Kent that have East Sussex post codes).

Rusthall is not mentioned – this is because the Royal Mail does not recognise Rusthall because it is not a Parish.

Action – Cllr Langridge to contact resident and update him.

Action - The Clerk will contact the Royal Mail and ask them to re-consider the use of the TN3 postcode.

Cllr Mrs Podbury asked if the committee had problems with the TWBC planning website and the universal response was that it was very difficult and unfriendly and often the site was down.

Action - She asked if the Clerk would write to TWBC to let them know of these difficulties and to consider redesigning it.

Cllr Mrs Podbury mentioned that it was necessary to review the Terms of Reference for Planning and this would be done as soon as possible.

Action - Clerk and Chairman to review.

Cllr Brown mentioned that he had heard that Holmewood House is starting a rebuilding programme.

Cllr Mrs Paulson-Ellis brought to the attention of the committee the High Court judgement regarding a house that had been built behind bales and the owners had lost their case.
