SE/17/00636 and 00637: Bovis Homes Ltd, The Manor House, North Ash
Road, New Ash Green, DA3 8JE – Installation of 7 number illuminated
bollards to existing pathway to frontage of the Manor House. Cllr Mrs
Connell PROPOSED that the Parish Council objects to this application due
to the massed impact on the street scene. The proposed lights are too
bright and too tall causing a danger to motorists as they cannot see past
the glare of the lights; there are too many and this conflicts with EN1, the
impact on the street scene; EN2, light pollution on neighbouring properties

and EN4, intruding onto the façade of a listed building.

Down lighters or low level lights would be more conducive to this rural setting and more in keeping with the lighting in the rest of the village. It was noted that if the correct lights are installed, there would be no requirement for a timer. Should this application be granted, the Parish Council would ask for a condition that the lights go off at 9.30pm as

proposed as this does not happen with the current lights.

The Parish Council would not object if all the lights were placed on the road side of the footpath, and the back of the light masked, so that only the pathway is illuminated and they were of a reduced height. SECONDED: Cllr Mrs Brammer and UNANIMOUSLY AGREED.

SE/17/00312: 56 Spring Cross, New Ash Green, DA3 8QQ – Erection of a first floor rear extension. Cllr J Kelly PROPOSED that the Parish Council does not object to this application as long as the amenity of the neighbouring property is not compromised. SECONDED: Cllr M Brown and AGREED.
