## SE/18/01324 and 01325: Martin McColl Ltd, 19-21 The Row, New Ash Green,

**DA3 8JB –** Erection of an ATM to be installed to the far right of the shop front and new white laminate security infill panel. The existing security roller shutter has been modified to allow constant use of the ATM.

Illuminated polycarbonate black and green surround signage with illuminated white lettering 'free cash withdrawals and balance enquiries' and illuminated signage to ATM fascia. Green acrylic sign with white lettering 'cashzone' and accepted card logos.
