

Minutes of the Annual General Meeting of Barnoldby-Le-Beck Parish Council, held virtually via Microsoft Teams on Wednesday 5th May 2021 at 7pm.

Councillor Hood having been duly nominated accepted the position of Chairman of Barnoldby Le Beck Parish Council and signed his Declaration of Office for the year 2021/2022.

Councillor Chapman was duly appointed as Vice Chairman for the year 2021/2022. Councillor Chapman having been duly nominated accepted the position of Vice-Chair. Councillor Chapman to sign and forward her Declaration of Office for the year to the Clerk.

09.05.2021 Open Forum:

Two members of the public attended the meeting and addressed the Council regarding the increased speed of vehicles since the removal of the chicanes, verges that are being churned up from a high volume of parked vehicles, the line of sight impaired by vehicles parking on the verges and wooden posts that were placed and now have to be removed. Councillor Hasthorpe said that Traffic Regulations Orders are in place on the Main Road and vehicles parking here risk penalty fines, he asked that the resident emails are forwarded so that he can investigate the concerns raised.

The Chair thanked them for attending and reconvened the meeting.

10.05.2021 To consider and approve the Minutes of the Meeting held on 31st March 2021. Proposed by Cllr Plaskitt and seconded by Cllr Bratton.

RESOLVED: The Minutes of 31st March 2021 were approved as a true record and the Chairman signed them.

11.05.2021 Police Liaison:

The Police report was distributed to Councillors prior to the meeting. There has been seventy four crimes across the whole of the Wolds Ward, of these there has been six incidents for Barnoldby le Beck. Chair noted that PCSO Di Bell has taken over responsibility for Wolds Ward from Richard Heseltine who has moved on to train to become a Constable.

12.05.2021 Planning items:

(a) to discuss any planning matters.

(1) DM/0353/21/REM - Plot 7 Kings Chase, Barnoldby le Beck.

Variation of Conditions 1 (Approved Plans) and 2 (Materials) as granted on DM/1039/18/REM for amended layout/design of dwelling and garage.

RESOLVED: The Parish Council reviewed and discussed the amended plans and agreed to approve this application with the condition for consideration during deliveries that trades people's vehicles park within the boundary and not on the verge/highway and the usual working hours applied.

(2) DM/0431/21/FUL - Plot 1 Kings Chase, Barnoldby le Beck.

Variation of Condition 2 (Plans) as granted on DM/0311/20/FUL to amend layout and design.

RESOLVED: The Parish Council reviewed and discussed the amended plans and recommended to oppose this application on the grounds that the plans has changed significantly to the original plans submitted on DM/0311/20/FUL and the detrimental impact this would have on neighbouring properties.

(3) DM/1084/20/REM - Land at Bradley Road, Barnoldby le Beck.

To discuss section 106. Councillors discussed and agreed that any money from section 106 should be spent within the Parish. Other concerns were discussed but agreed the concerns were not under debate for this agenda item.

13.05.2021 Clerks Report and correspondence received since last meeting:

(a) The Website planning tracker is being investigated by the Website provider. Clerk advised that the web provider and has confirmed that the development team has been asked to prioritise this issue.

(b) Remote meetings expire on 6th May 2021 at midnight and all future meetings should be held face to face. Councils must ensure that the meeting venue is COVID-secure.

(c) Clerk mentioned that she has not yet purchased the laptop and queried if the Microsoft Office 365 should be purchase as a yearly subscription or without. Clerk to obtain prices.

14.05.2020 Pavements/Street Lighting/Highways:

(a) To hear from chairman on meeting held with Highways Officer Debbie Swatman - Chair reported discussions took place regarding plans to replace the chicanes with traffic calming measures for which funding is in place, but has to be signed off by NELC. The main road through the village will be closed when the roundabout on Barton Street/Waltham Road junction is installed which will temporarily cut down the amount of traffic through the village. Debbie Swatman (NELC) did appreciate the fact that the Parish Council needs to be kept updated.

(b) Councillor Plaskitt reported that there is a lump of tarmac that has lifted on Chapel Lane corner. He also said that the road sweeper that he asked for has not yet been to sweep the roads in and around the village

Wolds Ward Barnoldby-le-Beck Update May 2021

Crime

There have been 74 crimes reported across the whole of the Wolds Ward from the date of the last update on 5th March. Of these there have been six reports in Barnoldby-le-Beck.

Following an incident on 12th April on Main Road, a male has been arrested for assault, making threats to cause damage and stalking which is part of a long running domestic situation.

In another long running neighbour dispute, a complaint of harassment has been made by one party against the other.

On 24th April, a car parked on Main Road was damaged after an implement was used to cause deep scratches in the bodywork. The other report relates to the sending of malicious communications.

There has been one report of ASB. On 27th April a report was made regarding youths causing issues at a fishing pond.

In other news, PCSO Di Bell has taken over responsibility for the Wolds Ward as Richard Heseltine has moved on to train to become a Constable.
