Comments: We consider this application to be an improvement of the previous application but we are still concerned that the flat roofed single storey side extension is still too close to the boundary hedge which may be at risk. Visually the single storey side extension looks unattractive with a flat roof and does not fit in sympathetically with the street scene.
