Members of the public attended the meeting and raised the following issues:

- a) Overgrown hedges at the junction of Tenbury/Ludlow Road The Clerk would refer the matter to Shropshire Council.

a) The Chairman and Mrs M M Clent referred to the recent public meeting held at Ludlow concerning the closure of a ward at Ludlow Hospital without Public Consultation. The closure of the ward was due to lack of appropriate nursing staff and although a ward had been closed the number of beds at the hospital had been retained with the 24 beds being accommodated into one ward.

To ensure the future of the hospital it was important that the proposed 25 year lease of the hospital to the National Health Service was agreed and signed by the 31st December 2015.

The Parish Council supported any campaign action for the retention of Hospital facilities at Ludlow.

- b) The Clerk reported that the telephone box at Caynham had been finally cleaned and that the post box at Caynham should be repainted early September 2015.
- c) The Chairman reported that The Playing Field at Caynham had been registered as a Community Asset despite an appeal by the Landowners.
