# (d) 16/505107/PNP – Storage Shed, Great Thorn Farm, Marden Thorn

Prior Notification for the change of use of a building and land within its curtilage from a use falling within Class B8 (Storage or distribution centre) to a use falling within Class 3 (Dwellinghouses). For it's prior approval to: Transport & Highways impacts of the development, contamination risks on the site, flooding risks on the site, noise impacts of the development, impacts of air quality on the intended occupiers of the development, where the building is located in an area that is important for providing storage or distribution of, or an increase in, a residential use of premises in the area would have an adverse on the sustainability of the provision of those services.

Marden Parish Council are not consulted. Cllrs feel it is not clear to the Parish Council whether there would be any transport or highways impacts because the number of housing units is unknown and it is unclear whether there are any air quality impacts arising from the existing and intended usage of the site.
