

## **Annex I – Mandatory Conditions**

### **I. Mandatory conditions where licence authorises supply of alcohol**

- (1) Where a premises licence authorises the supply of alcohol, the licence must include the following conditions.
- (1) The first condition is that no supply of alcohol may be made under the premises licence-
  - (a) At a time when there is no designated premises supervisor in respect of the premises licence

**OR**

  - (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) The second condition is that every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

1.-(1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance or harm to children-

- (a) games or other activities which require or encourage, or are designed to require or encourage individuals to-
  - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied to them on the premises before cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
  - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the act);
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;

- (d) provision of free or discounted alcohol in relation to the viewing of a sporting event, where provision is dependent on-
  - (i) the outcome of a race, competition or other event or process, or
  - (ii) the likelihood of anything occurring or not occurring:
- (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by the reason of disability).

3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

4.-(1) The premises licence holder or club premise certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

(2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

5. The responsible person shall ensure that -

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
  - (i) beer or cider. ½ pint
  - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - (iii) still wine in a glass: 125ml; and
- (b) customers are made aware of the availability of these measures.

## **2. Mandatory condition: exhibition of films**

(1) Where a premises licence authorises the exhibition of films, the licence must include a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.

(2) Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children must be restricted in accordance with any recommendation made by that body.

(3) Where-

(a) The film classification body is not specified in the licence

**OR**

(a) The relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question, admission of children must be restricted in accordance with any recommendation made by that licensing authority.

(3) In this section –

“Children” - means persons aged under 18

**AND**

“Film classification body” - means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification).

## **Environmental Health Conditions**

1. The DPS or a nominated representative shall receive and respond positively to any complaints relating to noise and/or antisocial behaviour throughout the duration of all noisy events.
2. The DPS should satisfy himself/herself that the sound level in respect of regulated entertainments is set to an acceptable level and should monitor levels throughout the night to assess whether the noise is likely to be disturbing to neighbouring residents.
3. Prominent, clear notices shall be displayed at exits requesting customers to respect the needs of local residents and leave the premises and the area quietly.
4. All external doors / windows must be kept closed, other than for access and egress, in all rooms when events involving amplified music or speech are taking place.

## **Other Conditions**

This licence is subject to the conditions and undertakings contained in the attached operating schedule.

## **Prevention of Crime & Disorder**

The members of our club are predominately in a mature age group and are unlikely to participate in unlawful activities or behave in a disorderly manner. However, at all times when the premises are open, a responsible member who will have an awareness of the possible potential for crime and disorder will be in attendance. Should suspicious behaviour is observed a search will be requested, in the event that a search is refused that person or persons will be asked to leave the premise. A notice to this effect will be displayed.

## **Public Safety**

The premises provide two main entrance and exit doors. In the event of an emergency, there are in addition one pair of double and two separate single emergency exit doors. Emergency lighting is installed throughout including illuminated exit boxes. Fire extinguishers and emergency equipment of the appropriate types are installed at various locations around the building in accordance with current legislation. All emergency equipment currently installed is regularly checked for compliance and serviceability.

## **Prevention of Public Nuisance**

The premises are located in a reasonably isolated position in an area not saturated with other licensed premises, in consequence the potential for public nuisance is considered to be minimal. It is however recognition that there are habitations within approximately 100 meters of the establishment and in entertainment involving amplified live or recorded music will be maintained at a reasonable level and only take place within the confines of the pavilion building. A noise pollution assessment has been carried out during previous social events held at the club and revealed that at 50 meters the sound emitting from the building is barely audible.

## **Protection of Children From Harm**

The club management committee and membership fully appreciate that children shall be protected from harm and in recognition of that and in order to monitor the possibility, the club management committee have appointed an appropriately qualified member to the position of child welfare officer. All minors within membership of the club have been informed that should they have any concerns, they must immediately report to their officer.
