

# Hartlip Parish Council

**Following the sad death of Her Majesty Queen Elizabeth II, the meeting of Hartlip Parish Council which was due to be held on Wednesday 14 September was cancelled as a mark of respect.**

**The meeting date fell within the period of official mourning during which the calling of new meetings was not possible as each day of public mourning was treated as a Sunday.**

The Parish Council has continued to operate as usual.

It was with great sadness that Hartlip Parish Council learned of the death of Her Majesty Queen Elizabeth II.

Her life was one of extraordinary dedication and service to the people of the UK, the Commonwealth and the World.

On behalf of the people of Hartlip the Parish Council has offered the deepest Condolences to Her Majesty's family at this sad time.

## **The Proclamation of Accession.**

The Accession Council met at St. James's Palace to proclaim our new Sovereign on Saturday 10 September where the Proclamation of Accession was read.

On Sunday 11 September it was read out by the High Sheriff of Kent and, later that day, by the Mayors of the Towns in Kent.

The proclamation of the new Sovereign is an ancient tradition which can be traced back over many centuries and when first introduced it was the way by means people learned for the first time that they had a new monarch.

For the first time ever, the Proclamation at St. James's Palace was televised.

The wording of the Proclamation is as follows:

**Whereas it has pleased Almighty God to call to His Mercy our late Sovereign Lady Queen Elizabeth the Second of Blessed and Glorious Memory, by whose Decease the Crown of the United Kingdom of Great Britain and Northern Ireland is solely and rightfully come to The Prince Charles Philip Arthur George: We, therefore, the Lords Spiritual and Temporal of this Realm and Members of the House of Commons, together with other members of Her late Majesty's Privy Council and representatives of the Realms and Territories, Aldermen and Citizens of London, and others, do now hereby with one voice and Consent of Tongue and Heart publish and proclaim that The Prince Charles Philip Arthur George is now, by the Death of our late Sovereign of Happy Memory, become our only lawful and rightful Liege Lord**

**Charles the Third, by the Grace of God of the United Kingdom of Great Britain and Northern Ireland and of His other Realms and Territories, King, Head of the Commonwealth, Defender of the Faith, to whom we do acknowledge all Faith and Obedience with humble Affection; beseeching God by whom Kings and Queens do reign to bless His Majesty with long and happy years reign over us.**

**Given at St. James's Palace this tenth day of September in the year of Our Lord two thousand and twenty-two.**
