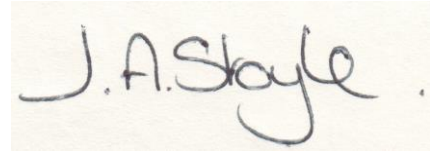

P21/S1906/HH Aleta Old London Road Milton Common OX9 2JR: Single storey orangery rear extension to replace existing conservatory and conversion of detached garage, re-positioned gated access.

Consultation end date 1st June 2021, target decision date 17th June 2021. The parish council have been given an extension until 9th June 2021, so the application can be considered at the June parish council meeting.

P21/S1077/HH Hartgrove Oxford Road Tiddington OX9 2LH: Create a new crossover. Planning permission granted on 29th April 2021.

P21/S1413/SCO Dodwells Solar Farm on Land North off The A40 Between Milton Common & Tetsworth: Scoping Opinion request in relation to application ref. P20/S3975/SCR. Scoping Opinion issued 13th May 2021.
