SC are struggling to get the resource for the traffic management, but this should be resolved WB 24/01/22.AGR Applications – The clerk has received the following response from Tracy Darke - Assistant Director Economy and Place at SC: AGR applications are a little confusing as they are not planning applications but we have to list them so everyone assumes there is an opportunity to comment on them. Effectively the local planning authority makes a decision on whether the development is permitted development or not. This is a decision which has to be made within 28 days against specific criteria (set out in legislation - Part 6 of the General Permitted Development Order 2015). It is or it isn't permitted development dependent on siting, size etc. It isn't an opportunity for the LPA or the public to have a view. If the decision is not made in 28 days, they can go ahead with the works. If it is not permitted development, then the application becomes a Full application. A Planning Officer will attend the next meeting to go through the process. | |
