337. **OPENING OF MEETING**

The Chairman opened the meeting at 7.30pm and wished everyone a Happy New Year.

338. **APOLOGIES**

Apologies were received from Cllr White. The previously notified reasons for absence were **ACCEPTED** and **APPROVED** and recorded in the absence book Ref. 601. Apologies were also received from KCC Cllr Andrew Kennedy and TMBC Borough Cllrs Cannon and Williams.

339. **DECLARATION OF INTERESTS**

There were no declarations of interests.

340. **CASUAL VACANCY**

NOTED no enquiries had been received as yet.

The Chairman advised that he unfortunately must declare another vacancy. He said that earlier in the day Cllr Mrs Dearden had written to him and the Clerk advising that she would be resigning from the Council with immediate effect. He advised he and the Clerk had responded and thanked Mrs Dearden for her hard work and service to the Council. Members agreed it was sad to hear this news and acknowledged Mrs Dearden's contribution to the work of the Council, in particular the improvements in the Community Centre over the last few years. It was confirmed that TMBC had been notified.

The TMBC Borough Councillors had contacted the Clerk to advise that there was nothing new to report from the Borough Council.

347. **REPORT FROM NEIGHBOURHOOD POLICE**

It was **NOTED** that PC Warner was currently on sick leave but the village was being covered by a colleague. The Clerk advised the only issue reported was some vandalism to trees and anti-social behaviour in the quarry. This had been reported to the police and the communication from the resident would be considered at the next Open Spaces Committee Meeting.

348. **DATE SENSITIVE PLANNING, HIGHWAYS AND TRANSPORTATION ISSUES**

(a) Plans Received for Comment

24/00372/PA - DEVELOPMENT SITE LAND EAST OF KILN BARN ROAD AND WEST OF, Hermitage Lane, Aylesford

Outline planning application with all matters reserved (except for access, which is to include the Sustainable Movement Corridor from New Road East Malling to Kiln Barn Road) for development of land to west of Hermitage Lane and East of Kiln Barn Road comprised of: a residential-led development of up to 1300 dwellings including affordable housing; a new village centre including a primary school; ancillary commercial, community and employment floorspace; strategic open space, parkland, child play provision and sustainable drainage infrastructure; new access points and associated transport infrastructure, including demolition of existing vacant buildings. Application supported by an Environmental Statement.

Planning application and Environmental Statement submitted under the Town and Country Planning (Environmental Impact Assessment) Regulations 2017

RESOLVED THIS COUNCIL CONTINUES TO STRONGLY OBJECT TO THIS APPLICATION AS A WHOLE AND OBJECTS TO THE PROPOSED MODIFICATION SUBMITTED IN DECEMBER 2025:

- The council accepts the adaption which will improve access for East Malling – particularly the church which was concerns from Historic England.
- The suggestion of hedge row has no legal standing and can be easily withdrawn or if part of the conditions – allowed to be modified. We have experience of what was believed to be clast iron agreements being removed years later.
- The concern of development of a large road will allow areas of high quality agricultural land to be available for housing. The suggestion in the TMBC plan for employment areas is unlikely.
- The route for a bus service still is relying on commercial partners – examples of this not being established on Panttoni Park suggest this is not viable
