#### 199. Minutes of the last meeting

The Minutes of the meeting of 22 November 2018, copies of which had been circulated, were taken as read and approved.

#### 200. **Declarations of interest**

Councillors were reminded that for those with any interest to be disclosed in relation to an item included in the agenda for this meeting, it was their duty to do so at the appropriate agenda item (as required to be disclosed by Section 96(1) of the LGA 1972, and in accordance with the Parish Councils Order 2001. Councillors had each received a form, which they were required to complete with any declarations of interest on an annual basis.

#### 201. Matters arising from the Minutes

#### a) Speedwatch

The SID machine had been rented for one occasion in December. A coordinator is needed, and it is hoped that one will soon come forward. Four further volunteers have also offered to help.

#### b) <u>Closure, Wolverton gate</u>

Vitaplay have been asked to provide a quotation for repair, but have asked for a site meeting prior to quoting.

c) land at junction of BR1 and Long Grove

Maintenance contractor had cleared the vegetation, but with difficulty, given the prickly nature of the shrubs planted there.

a) <u>BRT</u>

Fallen fence – possibility that this is a private fence fallen on County land. The situation to be monitored.

#### 202. County, Borough, BDAPTC and Police reports

- a) County Councillor Derek Mellor reported that:
  - HCC had now finalised budgets
  - Highways Engineer planning to inspect the area around Wolverton Common with a view to restoring the highway/signing, etc
  - The above visit may not prove viable, because of the foreseen disruption to the area, when used as 'rat-runs', once the planned building of thousands of houses begins on the Manydown estate, at the southern end of the A339, and the Newtown/Thatcham/Sandleford development at the northern end
  - No 14 bus will be cut to a 2 hourly service, with the exception of peak hours
  - Tadley Library has been reopened after refurbishment, and all are urged to use it
  - Council tax will be 2.99% from April 2019
  - No social care provision funding from the Government will be available to HCC this year, but they have not yet eroded their reserves with regard to this outlay
  - Devolved County Councillor grants parties interested in grant aiding should apply before 28 February 2019

- Questions raised included a request for HCC to investigate drain blockages under the highway outside The Malthouse in Snakey Lane
- b) Borough Councillor Michael Bound reported that:
  - There had been several changes to senior offices at BDBC
  - Elections will now take place in 2020 rather than 2019, with some exceptions
  - Postbox at the shops in Bishopswood Road had been replaced
  - Planning for 17 houses on land adjacent to Barclays Bank had been deferred
  - Application at Bishopswood Golf course for 18 houses and a hotel had been refused
  - Application for three agricultural dwellings at Church Lane, Wolverton, is going to Development Control committee as a retrospective planning application

The Chairman informed the meeting that, unlike other local district or borough councils, Basingstoke and Deane have decided not to charge parishes for elections which are not held at the same time as those for the Government or borough.

Two candidates were considered, and Mr Graham Hetherington was subsequently coopted and welcomed as a Councillor for Baughurst Ward.

#### 206. Playing fields and open spaces

a) Grass cutting for financial year 2019-20

Agreed that quotations would be sought for the coming year, with the minimum and maximum number of cuts set between 5 and 7 per year, and invoicing on a monthly basis.

#### b) Greenham Common Trust

The Trust had indicated that they may look favourably upon a grant aid request for play areas, offering match funding. Agreed that this should be considered at the next Playing Fields and Open Spaces meeting.

- Misleading signs on the gate leading past West View Farm, stating 'Private land –
  please keep dogs on a lead'. It looks as though the public should not go through the
  kissing gate, although this IS waymarked.
- Kissing gate at junction with field not waymarked.
- Stile at end of field before junction with Violet Lane completely collapsed, and very difficult to climb under or over.

#### Footpath 19

- Fingerpost wrecked at junction with Violet Lane
- No issues from Violet Lane, across Witches Gulley and to Baughurst Road.
- Fingerpost wrecked at junction with Baughurst Road.

#### Footpath 22

- Gate has dropped contractor to be asked to take a look.
- Vegetation needs clearing back overhead.

#### Footpath 21

From junction with FP22 to FP16, no issues.

#### Bridleway 15

- Still very soggy, despite hardcore having been deposited.
- Fingerpost wrecked at junction with Baughurst Road.
