### 2357/25) To receive the Chair's report

Cllr Skelton read out his report\* and added thanks to Retford Lions for facilitating a further defibrillator training session this week. It means there are now more residents trained on how to deal with an emergency situation.

### 2358/25) To suspend the meeting to hold a 10-minute public session

One resident thanked the parish council for arranging the CPR training session, and stated that a question had been lodged to be asked at the full Bassetlaw District Council meeting next week regarding the planning refusal of the Brough Lane site. There was a discussion surrounding the subject of the unauthorised development.

### 2359/25) To receive reports from the District and County Councillors

Cllr Adams reported that there are two enforcement officers working on the Brough Lane site case, and confirmed there is a full Council meeting on Thursday 4 December at 6.30pm, which the public are welcome to attend. Cllr Skelton urged residents to attend to show support to the village.

Cllr Wright reported on several visits he had made, including a meeting with ViaEM regarding the pavements in the village. He confirmed that they would be repaired in the new year, and Cllr O'Brien thanked him for using all his appropriate funding for this job. Cllr Wright expressed his dissatisfaction with Bassetlaw District Council's (BDC) dealings with anti-social behaviour. He continues to arrange veterans' clinics, and drive Adult Social Care as Deputy Cabinet Member for Nottinghamshire County Council.

### 2360/25) To receive update on the Neighbourhood Plan review

The Neighbourhood Plan Review was accepted by referendum on 13 November, and will now be used by Bassetlaw District Council to help it decide planning applications in the

A couple of new things I would like to trial this month...

Firstly, if we have anyone that doesn't necessarily want to be a Parish Councillor but has an interest in the village and how we future proof and develop it, we would love to have you on board to give us a dig out with projects and any other tasks we undertake.

We only have a limited number of hands and your Parish Councillors only have so many hours to give. We would love to work on all the projects and agenda items we discuss but time, energy and abilities sometimes prevent us gaining as much traction as we can.

Do you know anyone who could or would be willing to help?

Secondly, we don't often have too much input or many ideas raised by you, the residents. As a Parish Council we are always looking at ways to be innovative, productive and efficient and maybe once again, some of you have thoughts and ideas on things that affect the village good and bad. If so, we would be really keen to hear them and bring them to this forum for future discussions.

Onto what we've been doing as your Parish Council this last month, we as a collective have spent in excess of 20 hours doing the things that matter, things such as:

- Christmas event planning.

As you can see, a lot of what we do goes on behind the scenes and it's not always obvious how much work and investment we as a Parish Council are making in the background.

in the Hall, to being a part of the Elkesley Village Plan assembly, promotion and input. It really is humbling that we have such a vast amount of knowledge within the village and people who are willing to get involved.

On that note and I will speak personally as a one off. Thanks to all who turned out to vote and what a resounding win for the community. It's good to see common sense prevail and Elkesley hold the title deeds to our own future.

Regardless of personal opinion and some negative dialect, I will stand fast and will always advocate our village being in charge of our own destiny where we can. It is my intention that my letter reaches the top in order to invoke communications and conversations with those who can have an input and address some of our wants and concerns. This has been long overdue and this is now the vocal point of each and every meeting until resolution. We will have this topic as a standing agenda item until further notice, I will now share my intended letter.\*\*

Onto a lighter note, for those who don't know, so far we now have pledges from other businesses within the area who have agreed to match Starbucks.

Eco Prime and A1 metals from Jockey Lane have now also pledged £250 each per year to the Parish Council to go towards defibs, maintenance and other life-saving equipment. This means each year as a minimum we will receive £750 for the upkeep and replenishment of items.

The money has already been received and more than £400 of this has already been well spent on the new plastic defibrillator cabinet housed at the Best One Shop. Thanks to Kumar and Abiya for their continued support and selfless kindness to the village.

Also massive thanks to Scott Redfern for fitting the cabinet for us, very decent of him.
