Minutes of the Meeting of the Parish Council held at 7.30pm on Monday, 1st December 2003 in the Village Hall

1 Apologies for Absence

2 Minutes of meeting held 21st October 2003

The minutes of the above meeting were approved and signed as a true record.

3 Matters Arising

a) Dog Fouling

Discussion followed and it was thought that the two bins requested at either end of the lane in question were not yet in place. Also the laminated posters were not to hand. It was decided Mr Nigel Barton, BDC's Animal Warden be contacted to check as to whether he had made an inspection of the lane, chase the bins and posters, and once these are in place, request Mr Barton do a leaflet drop in the village. **ACTION: S Pickard**

b) Manor House Farm, East Drayton

The Clerk reported she had returned the Comments form and a letter had been sent to Bassetlaw District Council giving more information about the felled tree. No reply, to date, has been received.

c) The Limes, Low Street, East Drayton

The Clerk advised she had spoken to Lisa Reynolds in the Planning Department at Bassetlaw District Council concerning the dog kennels and recent fencing at this property. They stated that if the kennels were for commercial use then an application to Bassetlaw should have been made. Also, even if they were for personal use, if the structure was large, they should have been contacted. Discussion followed and it was agreed to contact Bassetlaw again and request a site visit. **ACTION: S Pickard.**

d) Manor Park, Darlton Road, East Drayton

Cllr Allen asked if there had been any further news concerning the car park under construction at Manor Park. The Chairman advised she had been in contact with Bassetlaw concerning this matter, but had heard no further. It would seem the car park (for at least 30 cars) would stay and there would be no screening from the road by shrubs (as shown on plans previously submitted to the Parish Council), thus making it look like an industrial site on entry to the village. The situation was explained to DCllr Sutton and much discussion followed concerning the way the Planning Department operates. It was felt that the plans approved should be adhered to and property built accordingly. DCllr Sutton noted the Parish Council's concerns.

i) Nicholas Hawksmoor plaque

Mrs Taylor, a resident in the village, asked the Parish Council to give consideration to recognising what she considered one of East Drayton's most famous sons – Nicholas Hawksmoor (a contemporary of Sir Christopher Wren). She proposed a heritage plaque be mounted on the new lytchgate. Mrs Taylor then gave a potted history of the Hawksmoor family to reinforce her keenness for this project. Cllr Goddard explained that the original Nicholas Hawksmoor plaque had been damaged several years ago. Discussion followed and it was pointed out that it is Church policy not to allow plaques. Alternative sites were suggested: the Church porch/in the Church/in the village hall. It was AGREED the Chairman seek advice and approval from Canon Jean Calvert in the first instance, and then if appropriate, Cllr Jones to contact Mr Langford.

The Chairman thanked Mrs Taylor for attending and she left the meeting, escorted by DCIIr Sutton, at 8.15pm.
