Therefore, if a casual vacancy arises between now and 6 May (the day on which your current councillors will retire), your council may co-opt to fill this but is not required to seek to do so and there are no requirements in relation to advertising this locally. As there is limited time between now and the scheduled elections for all parish and town councils in May 2019, your council may decide not to fill any vacancy and instead operate with a reduced number of councillors. Providing that you have enough councillors for your meetings to be quorate, that is no problem."

Historically, the elections for the majority of smaller local councils have not been contested and we do not anticipate that there will be any change to this trend. As you will recall our original proposal was for the public conveniences in your Parish to be transferred freehold together with a cash sum to cover refurbishment and two years running costs. You may also be aware that the District Council's decision on devolution of assets and services was subsequently reviewed by the Shadow Executive of the new Unitary Authority but was not supported. As a result the cash sums which had been envisaged as part of the programme are no longer available. I have been asked now to contact you in order to clarify the position and to ask for your formal response to the District Council's amended proposal. Under the Shadow Executive Principles if public conveniences are to be transferred this may only be done on a leased basis with a proviso that if the Public Convenience is ever closed then the asset reverts to the new Unitary authority. The Public Conveniences in your Parish could now be transferred on a 30 year lease at a peppercorn rent and while no funding is available for refurbishment the District Council would attempt to address any maintenance issues before transfer. The transfer would therefore take place on the basis that the Parish Council agrees to fund the management and operation of the service from the date of transfer. I would be grateful if you could therefore arrange for your Parish Council to review the amended proposal and let me know, as soon as possible ,whether or not it would be prepared to proceed on that basis. Any transfer agreed would need to take place on or before the 30th March 2019."
